In producing herewith one accused person namely Benoy Rai(M/20) S/O Late Deepak Rai of Namchi, P.S. Namchi, Gangtok, South Sikkim under arrest along with following articles under proper seizure Viz :- (i) One paper made cartoon containing 12(twelve) bottles of "HAYWARDS BOLD" Strong Beer contains 650 ml in each bottle i,e. total(12 X 650ml = 7.8 liters) Marked as exhibit "A", out of which 01 (one) bottle of "HAYWARDS BOLD" Strong Beer contains 650ml is taken as sample from Exhibit "A" for examination and marked as Exhibit "A-1", (ii) One paper made cartoon containing 12(twelve) bottles of "KINGFISHER" imperial Strong beer contains 650 ml in each bottle i,e. total(12 X 650ml = 7.8 liters) Marked as exhibit "B", out of which 01 (one) bottle of KINGFISHER imperial beer contains 650ml is taken as sample from Exhibit "B" for examination and marked as Exhibit "B-1", (iii) made cartoon containing 12(twelve) bottles of "TUBORG" premium Beer Strong contains 650 ml in each bottle i,e. total(12 X 650ml = 7.8 liters) Marked as exhibit "C", out of which 01 (one) bottle of TUBORG premium beer Strong contains 650ml, taken as sample from Exhibit "C" for examination and marked as Exhibit "C-1" and (iv) One paper made cartoon containing 10(ten) bottles of "HIMALAYAN GOLD" 60 UP India made liquor contains 600 ml in each bottle i,e. total(10 X 600ml = 6.00 liters) Marked as exhibit "D", out of which 01 (one) bottle of "HIMALAYAN GOLD" 60 UP India made liquor contains 600 ml is taken as sample from Exhibit "D" for examination and marked as Exhibit "D-1" (Total-29.4 liter);

I, ASI Tubai Roy of Pradhan Nagar P.S under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person namely Benoy Rai(M/20) S/O Late Deepak Rai of Namchi, P.S. Namchi, Gangtok, South Sikkim to the effect that on 25/07/25 at around 22:10 hrs, I received specific source information that the owner of Durga Hotel situated at Siliguri Junction under Pradhan Nagar P.S possessed and stored large quantity of illicit liquor without any valid license or documents and was engaged in selling the same to the public customers. Upon diarizing the information vide. Pradhan Nagar PS GDE No. 1624 dated 25.07.2025, I informed you about the matter. As per your direction, I proceeded to the mentioned location accompanied by ASI Sajal Das, C/1446 Nirmal Roy and C/1132 Santu Das of Pradhan Nagar PS with Govt. vehicle and investigation kits.

At around 22:25 hrs I along with the above mentioned officer and force arrived at Durga Hotel, Siliguri Junction under PS- Pradhan Nagar, Dist. Darjeeling and being pointed by the source we managed to one person. We informed him about the information in hand. During interrogation, he disclosed his name as Benoy Rai (M/20) S/O Late Deepak Rai of Namchi, P.S. Namchi, Gangtok, South Sikkim who introduced himself as staff of the hotel and admitted to procuring and selling illicit liquor without any license for personal profit and revealed that he along with the owner of the hotel named Roshan Lama had been involved in such illegal activity for a few months. On further search, we recovered the above seized articles from his exclusive possession.

ALT TWOOD CONS

As he and the owner of the hotel willfully violated the norms of Bengal Excise Act, hence, I seized the above noted illegal illicit liquor from his possession under proper seizure list in presence of the individual witnesses. The entire process of search and seizure was made in between 22.40 hrs to 23.02 hrs under the coverage of videography as per provisions of BNSS. Subsequently, I arrested the above noted detained person after observing all the formalities of arrest informing him regarding ground of arrest in written for violating the norms of Bengal Excise Act.

Under the above noted fact and circumstances I, therefore pray that a specific case under proper section of law may kindly be started against the above noted arrested accused person namely Benoy Rai(M/20) S/O Late Deepak Rai and the owner of the hotel Roshan Lama for violation of the provisions of W.B. Excise Act and may arrange to cause its investigation.
