Sir,

In producing herewith the following seized articles as per seizure list viz :- (i) One Truck having registration number WGY-4905 loaded with illegal River bed materials. I, ASI Biplab Kr. Das of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the driver and owner of the above mentioned seized vehicle having registration number WGY-4905 to the effect that today on 26.07.2025 at around 21.05 hrs, I received a specific source information that illegal mining of river beds materials is going on Mahananda river bed at Military Ghat under Pradhan Nagar P.S. Dist. Darjeeling and the owner and driver of the said vehicle loaded river beds materials illegally in their truck to sell the same to their design customers for their illegal gain. Accordingly, I diarized the matter in PS General Diary vide Pradhan Nagar PS GDE No. 1673 dated 26.07.2025 and informed the matter to you. As per your kind order and direction I along with force left for Mahananda river bed, Military Ghat to verify the veracity of the information by Govt. Vehicle. On the way I received source information that the said vehicle loaded with illegal river bed materials proceeding towards Champasari Anchal.

At around 21.30 hrs we reached at Champasari Anchal near Sriguru Vidhyapith and from a considerable distance we noticed that seeing our police van the said vehicle trying to flee away but failed. The driver of the said vehicle run away keeps the vehicle on road side at Champasari Anchal. We were tried to apprehend the driver of the said truck but in vain. We found that the said truck loaded with illegal river bed materials. We searched the owner of the said vehicle (Track) having Registration number WGY-4905 but the owner and driver both are found absconding. During enquiry, it is reveal that the owner and driver of the vehicle having Registration number WGY-4905 illegally mines river bed materials from Mahananda rivar by illegal means and loaded the same in the vehicle to sale the same to their design customers for their illegal gain. Accordingly, I seized the above mentioned vehicle (Track) having registration number WGY-4905 loaded with illegal river bed materials in proper seizure list from the spot under section 106 BNSS. The entire process of search and seizure was made under the coverage of videography in between 21.45 hrs to 22.05 hrs as per norms of BNSS and brought at Pradhan Nagar PS/SPC for further investigation.

Under the above circumstances, I, pray before you that a specific case under proper section of law may kindly be started against the owner and the driver of vehicle having registration number WGY-4905 and arrange for its investigation.
