No. 6296768905), I, SI Goutam Mallik of Pradhan Nagar PS, SPC, do hereby lodged this written complaint against the following three arrested accused persons namely (i) Goutam Ray (M- 28 yrs) S/O Rama Shankar Ray of Surya Shikha Sarani Road, Ward - 39, Haidarpara, PS-Bhaktinagar, Dist- Jalpaiguri, (ii) Petrus Beck (M-42 yrs) S/O Sylbanus Beck of Zurrantee Tea Garden, Dele Line, PO & PS, Metlli, Dist Jalpaiguri and (iii) Jayshree Paul (F-32yrs) D/O Hare Krishna Paul W/O Swarup Bhowmick of Amar Sarani, Janata Nagar, W/No. 44, Sevoke Road, PS Bhaktinagar, Dist Jalpaiguri to the effect that today i.e. on 27.07.2025 at 14:55 hrs, I received a specific secret source information regarding carrying of good numbers of young girls illegally from different Tea Gardens of Doors side to Chennai via Siliguri and Ranchi. One Goutam Roy of Haiderpara, PS Bhaktinagar, Dist.-Jalpaiguri along with two others would receive them at Prodhnan Nagar near Junction and there after they would arrange for a Bus to carry those innocent girls to Chennai via Tamilnadu Jharkhand.

Accordingly, the matter was diarized in PS General diary vide Pradhan Nagar PS GDE No. 1714 dated 27.07.2025 and informed the fact to you. As per your kind order and direction myself along with SI Rajiv Subba, SI Sumit Sarkar, SI Bandhan Roy, SI Bijay Sarkar, ASI Biplab Kr Das, LASI Mithu Kabiraj, and force left for Siliguri Junction under P.S- Pradhan Nagar, Dist. Darjeeling to verify the veracity of the information. At around 15:10 hrs, we arrived at Siliguri Junction and contacted with my source and he up dated me that the bus having registered No. WB 41K 1650 was reserved by accused persons noted above for carrying of those victim girls and the Bus would depart from "Adhi Sakthi Tour and Travels Counter", Siliguri Junction near Bharat Petrol Pump, under PS- Pradhan Nagar, Siliguri. Accordingly I briefed my team and we cordoned the place from every corner with due care and caution.

After a while we noticed the movement of 3/4 groups of girls near the said Bus Counter at Siliguri Junction area and also found some girls were sitting inside a bus Counter. Then with due care and caution we cordoned the place from every corner and noticed that the bag and baggage were loaded inside the bus under the direction of two male persons and one female person. Being pointed by the source we managed to detain 3 persons including one female by whose direction the bag and baggage were loaded inside the bus and also rescued the above mentioned 34 (thirty four) victim girls. On interrogation the accd persons disclosed their identities as mentioned above. On further interrogation they revealed that they targeted those girls who belong to poor families of different Tea Gardens and rural areas of Alipurduar, Darjeeling, and Jalpaiguri Districts. Then they entangled the victim girls as well as their families by inducing them to provide good opportunity to earn money in a prestigious Company in Tamilnadu namely "SP Apparels Limited".

I also examined all the recovered victim girls in presence LASI Mithu Kabiraj of Prodhnan Nagar PS and during examination most of the victim girls gave similar statements regarding allurement and for providing job and also disclosed that they were not confirmed about the nature of job, place of job. We gave adequate time from our end to all the three detained persons and rescued girls to provide valid documents of any legal Govt, office for procurement and transporting such huge numbers of girls from one state to other states in the name of giving job. But they failed to produce any such valid document or authorization. On further examination of the above mentioned rescued girls and their parents it is learnt that they were not aware about the actual purpose of their journey and simply answered that they were going to Tamilnadu for work.

Under the above noted facts and circumstances there is strong reason to believe that the said three accused persons namely (i) Goutam Ray (M- 28 yrs) S/O Rama Shankar Ray of Surya Shikha Sarani Road, Ward - 39, Haidarpara, PS-Bhaktinagar, Dist- Jalpaiguri, (ii) Petrus Beck (M-42 yrs) S/O Sylbanus Beck of Zurrantee Tea Garden, Dele Line, PO & PS, Meteli, Dist Jalpaiguri and (iii) Jayshree Paul (F-32 yrs) D/O Hare Krishna Paul W/O Swarup Bhowmick of Amar Sarani, Janata Nagar, W/No. 44, Sevoke Road, PS Bhaktinagar, Dist Jalpaiguri, in order to exploit the girls, after hatching a conspiracy in connivance with others, recruited, those girls from different Tea Gardens and areas of Darjeeling, Jalpaiguri and Alipurduar Districts having poor and ignorant back ground by inducing them to give huge benefits and started to transport them to uncertain destinations in Tamilnadu. The accd persons are the commissioned agents and they confessed that for their wrongful gain, they were contacted to get commission of Rs 4000/ per girl from the receiving Unit viz SP Apparels, Avinashi, Tamilnadu. Then, I arrested them informing them the ground of arrest in writing. I also seized two tickets issued by ANAND LXURY to Gautam and SP Apparels Ltd, for total 41 persons for journey from Siliguri to Ranchi following legal procedures.

I, therefore pray before your good self that a specific case may kindly be initiated against the accused persons namely (i) Goutam Ray (M- 28 yrs) S/O Rama Shankar Ray of Surya Shikha Sarani Road, Ward - 39, Haidarpara, PS-Bhaktinagar, Dist- Jalpaiguri, (ii) Petrus Beck (M-42 yrs) S/O Sylbanus Beck of Zurrantee Tea Garden, Dele Line, PO & PS, Meteli, Dist Jalpaiguri and (iii) Jayshree Paul (F-32 yrs) D/O Hare Krishna Paul W/O Swarup Bhowmick of Amar Sarani, Janata Nagar, W/No. 44, Sevoke Road, PS Bhaktinagar, Dist Jalpaiguri and others under proper section of law and its investigation may kindly be arranged
