Sir,

I, **SAIFUL ISLAM**, S/o Md. Samsul Haque, the Manager of "**THE ROX**" Singing Bar situated at Upper Bhanu Nagar, Ward No. 43 S.M.C., P.O. Sevoke Road, P.S.-Bhaktinagar, Dist-Jalpaiguri in the State of West Bengal, would like to lodge this Written Complaint to the effect that on since last 10 to 15 days a group of some anti-social persons namely 1) **BIJAY SARKAR**, Son of unknown, 2) **SHAHNAWAJ HUSSAIN**, Son of unknown, 3) **RINKU**, Son of unknown along with 10-15 others are visiting at our Singing Bar on frequent basis and after receiving the Service from our above mentioned Singing Bar they show their reluctance for paying bills and upon request for payment of the Bill they create nuisance, assault upon the Staffs, misbehaving the lady staffs and give ill proposal and also doing other illegal acts.

Sir, it is to be mentioned here that on 17.07.2025 the above mentioned persons visited the Singing Bar above named and they received different services and after having the services, the staff asked for the payment of the Bill amounting Rs. 12,730/- (Rupees Twelve Thousand Seven Hundred Thirty) Only, but the above mentioned persons denied to pay a single penny on the other hand they started to create nuisance and chaos inside the Singing Bar and they broke the glass, door, tables and other interiors and they also assaulted the staffs of the Bar.

Sir, it is to be mentioned here that the above mentioned persons asked for Rs. 50,000/- (Fifty Thousand) protection money (Hafta) for our lawful business by showing sharp weapon by putting our staffs in fear and they further warned that they will not allow us to continue our lawful business and they went outside the bar and fled away without paying the Bill.

Sir, again on 22.07.2025 the above mentioned persons again came to our bar and again had different services and this time they molested our Bar's Lady Artist and they gave some wrong proposal to them and they have threatened them to spoil their life and it is to be mentioned here

that and after having the services, the staff asked for the payment of the Bill amounting Rs. 12,770/- (Rupees Twelve Thousand Seven Hundred Seventy) Only, but the above mentioned persons again denied to pay a single penny on the other hand they started to create nuisance and chaos inside the Singing Bar and paid only a sum of Rs. 2750/- (Rupees Two Thousand Seven Hundred Fifty) only from Rs. 12,770/- and denied to pay a sum of Rs. 10,020/- (Rupees Ten Thousand Twenty) only and on asking for the rest amount they again demanded Rs. 50,000/- as protection money (Hafta).

Sir, again on 26.07.2025 the above mentioned persons again came to our bar and again had different services and this time they had services amounting of Rs. 16,250/- (Rupees Sixteen Thousand Two Hundred Fifty) only and they left our Singing Bar Without paying bill.

Sir, it is to be mentioned here that on different occasions the above mentioned persons had taken the services and did not pay the money in addition to it they have not pay the collection of Lady Artist amounting the Rs. 1,80,000/- (Rupees One Lakh Eighty Thousand) Only and they have threatened the Lady artist to Leave Siliguri within 29.07.2025 otherwise the above mentioned persons will ruin the lives of the Lady Artists.

Sir, the above mentioned persons have also threatened me and other staffs that not to disclose the facts to Police otherwise they will kill me and my entire staffs as they are having very good relation with the anti-socials.

Sir, the above mentioned persons are very dangerous and in present situation it is very tough to do our lawful business smoothly and this entire incident is recorded in the C.C.T.V.

Therefore, in such situation I am taking the shelter of law, Kindly do needful as per law against the wrongdoers
