Sir,

I do hereby lodge a complaint empowered by the Electricity Act, 2003, read with further amendments that Mrs. Shila Bhowal, W/O- Praneshwar Ch. Bhowal (Permanent Address: P.C. Sarkar Sarani, Hakimpara, Ward- 15, P.O. & P.S.- Siliguri, District- Darjeeling), Inspection Address: Bholanathpara (Behind Mahalaxmi Weigh Bridge), P.O. - Ghogomali, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Consumer ID: 402232037), has committed Theft of Electricity under section: 135(i)(a) & 138(b) of the Electricity Act, 2003, read with further amendments for the Commercial purpose as stated here under.

On 28.07.2025 at about 14:05 hours, I, Sri Sourav Paul, DE (E) & Station Manager, Subhaspally CCC, WBSEDCL, along with 1. Mr. Bijoy Lakra, DE(E), 2. Mr. Bhaben Roy, Special Officer, attached with S&LP unit, Darjeeling Region, WBSEDCL & 3. Mr. Arnab Ray, JE(E) (Grade-II), 4. Mr. Anup Lama, Sr.OE & 5. Mr. Mangru Baraik, Hg.TSH, attached with Subhaspally CCC, WBSEDCL, entered into the Commercial premises of Mrs. Shila Bhowal, W/O- Praneshwar Ch. Bhowal, Address: Bholanathpara (Behind Mahalaxmi Weigh Bridge), P.O.- Ghogomali, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Consumer ID: 402232037), in order to inspect the incoming service line as well as Supervisory Checking purpose.

During inspection, the aforesaid accused, Mrs. Shila Bhowal, W/O- Praneshwar Ch. Bhowal, Inspection Address: Bholanathpara (Behind Mahalaxmi Weigh Bridge), P.O.- Ghogomali, PS- Bhaktinagar, District- Jalpaiguri, PIN- 734006 (Consumer ID: 402232037), was found consuming Electricity dishonestly in unauthorized manner by Unauthorized Reconnection of the 'Deemed Disconnected' service connection having Consumer ID: 402232037 & Meter No.: T02695391 which was disconnected on 16.11.2019 due to having outstanding dues of electricity of Rs. 21,737.23 (excluding LPSC). Moreover, the last meter consumption up to which billing was raised is 2400 KWh. And, during inspection on 28.07.2025, the aforesaid service connection was found 'Physically Live' by unauthorized reconnection of the disconnected service line as well as found consuming electricity through that meter installed in her earmarked Commercial premises for Commercial purposes. The Energy Meter: T02695391 was found performing 'Normal' having last reading of 3782 KWh (Maximum Demand: 2.33 KW) during seizure of the meter. Thus the service connection was used in unauthorized manner & no further billing could have been possible, because of which WBSEDCL incurred huge amount of loss in revenue.

As the unauthorized use had been detected I immediately with the help of my Technical staff disconnected her Service Connection and seized one number single phase Energy Meter having Device SI No.: T02695391, Make: L&T, Rating: 240V, 5-30A, 50Hz, 3200 imp/KWh (L.R.: 3782 KWh) connected with some portion of Incoming & Outgoing wires, which have been used for the aforementioned unauthorized & dishonest use viz-a-viz Pilferage of Electricity (Consumer ID: 402232037, Nature of Use: Commercial), under a proper seizure list & the seized articles were properly packed, labeled and sealed at the spot after observing necessary formalities in presence of the Inspection Team Members & other Witnesses & Witness of the Accused Person (i.e. Son). The inspection team members left the aforesaid premises at 15:05 hours on the same day after observing all formalities.


