Sir

With due respect and humble submission I ASI Aibul Islam of Matigara P.S. beg to submit that on 28/07/2025 myself along with force were detailed to perform Mobile Patrol duty, vide C.C. No. 2326/25, Dated 28/07/2025 and GDE No. 1474, Dated 28/07/2025. During my said mobile van duty, I received a source information that one Tractor loaded with river bed material is coming from Tarabari side, P.S. Matigara, having no document/Royalty in respect of said load. Accordingly I informed the matter to I/C Matigara P.S., over phone. After hearing the information he directed me to work out over the information at once. Accordingly I along with force rushed to Asian Highway - 2, near Magurmari Bridge, under Matigara P.S. Seeing the police party, driver/owner of the vehicle fled away, keeping the Tractor bearing no. WB74BP3149, fitted with trolley, loaded with riverbed materials abandoned. It may be presumed that the Driver/Owner of said Tractor procured the loaded riverbed materials, illegally and dishonestly, stealing by unfair means from Tarabari Ghat, P.S. - Matigara, for their wrongful gain and trying to proceed to deliver the same to their designated customer. I searched for the driver/owner of said vehicle but in vain. Nobody came forward to claim the vehicle. Finding no other alternatives, I seized the Tractor bearing no. WB74BP3149, fitted with trolley, loaded with river bed materials, preparing proper Seizure List also brought the tractor to PS. Search and Seizure was made in between 11:19 hrs to 11:25 hrs on 28/07/2025 under proper videography.

Therefore, I pray before your kind honour that a specific case may kindly be registered against the driver/owner of Tractor bearing Regn. no. WB74BP3149, fitted with trolley, loaded with river bed materials, and arrange for it's investigation.
