Sub: Complaint against Husband and in-laws.

Respected Sir,

With due respect I am Rikta Mahanta, Wife of Sujan Mandal, Daughter of Shekhar Mahanta residing at Matigara Bhangapul, Mathapari, P.O. & P.S- Matigara, Dist- Darjeeling, West Bengal -734010, Would Like to inform you that on 01/02/2021, My marriage was solemnized with one Sujan Mandal S/O Late. Nakul Mandal resident of Uttar Shantinagar, Pangani para, Near Dhakeshari Mandir, Dabgram (P), PO & PS Ashighar, Dist- Jalpaiguri as per Hindu rites and customs and since then I was staying in my matrimonial house with my husband, my Mother in-law (Mina Mandal), Brother in-law (Chandrasagar @Tapash Mandal), Aunt in-law (Bina Mandal W/O Sahadeb Mandal).

It is Pertinent to mention here that our marriage was arranged one and at the time of marriage gold jewelries amounting RS- 4,00,000.00 approximately (Rupees four lacks only) along with others households articles like Box Divan (Khat), dressing table, Showcase, Almirah, Home Theatre, T.V, Smart Phone, Alnah (Cloth rack stand) etc. and handed over cash Rs.50,000.00/- (Rupees Fifty Thousand Only) where given to my husband and his family as per their demands, though from the day one they started complaining regarding the quality of those articles, I was subjected to mental torture from the very beginning for demanding more cash from my parental house which was refused by my father. Thereafter they were started physical torture upon me, after few days I came to know that my husband is alcoholic, every night he consumed alcohol and after he came into the house started filthy languages upon me and pressurized me to ask for money from my father, whenever I denied he used to hit me very badly, the amount of torture was increased day by day eventually it came to the extent of physical

assaults as I was unable to provide them further dowry. After few days my husband started pressurizing me to earn money by way of prostitution, my husband used to say that he has connection with many influential and wealthy people, sleeping with them can make us rich.

On 05-08-2021 I came to know that I was pregnant and I was very happily announced the good news to my husband and my mother in-law suddenly they become violent and used filthy languages upon me and pressurized me for abort the child in my womb when I denied they pressed my neck very tightly, and tried to killed me, and also warned me not to inform the matter to my father, when I became sense less they left me. On 10-08-2021 they brought a medicine and told me to consume that when I asked them what kind of medicine is that? they told me to consume without asking any question, and when I denied they feed me the medicine forcefully, after few hours I was suffering from lower abdomen pain and started bleeding from my private part, but they didn't provide any medical facility to me. After few days when I was stable I informed my parental house about this incident, and when my parents asked them the reason of this kind of activity they told this is none of your family matter anymore assaulted my parents with filthy languages. Thereafter when I tried to shifted in my parental house, my husband and my mother in-law remorse to me and assured me that this kind of incident mistakenly happened by them and it will not be happen in future. Thinking about my domestic life I stayed there for a bright and healthy future.

After few days my husband again started physically and mentally torture upon me regarding demanding money from my father. Even my father think about my healthy life given him such money amounting Rs.50,000/- (Rupees Fifty Thousand) only but their torture didn't stopped anymore. On the year of 2022 I become pregnant again and on 02-12-2022 I gave birth of a baby boy (Rishu Mandal age 2.5 years). At the time of my delivery my husband and my in-laws pressurized to my father that they were unable to bears my delivery expenditure and my father had to

pay all this. Even my father bears all this expenditure what they demanded. After my delivery my husband again started torture upon me for demand money from my father. And I bound to ask my father and from that time to still now my child's every necessary fulfilled by my father.

Even I also mentioned that in daily life my mother-in-law, Aunt-in-law, Brother-in-law, husband interfere in my every activity (like cooking, dusting etc.) by using filthy languages. If I forget to do anything they started beaten up me. One day my Aunt-in-law ask me to comb my hair and at the time of comb my hair she intentionally cut my hair from back side abnormally and told me 'You deserve ugly look'. Once upon a time in morning I enter into the kitchen for cooked, I realized that the Gas Oven was switched on condition and the gas cylinder was continuously leaking, I understood my mother-in-law came into the kitchen and intentionally tried to kill me by burn. Whenever I said this all to my husband about this kind of incidents, he always told me I am a liar, his family members never did this. That time I thought they do this all mistakenly but day by day I understood that they were intentionally torturing me physically & mentally.

On 18/07/2025 at the time evening suddenly my Aunt-in-law came in our house and accused me to theft some vegetable, cake and Biscuit theft from her house and that time my mother-in-law, husband and brother-in-law was present in the premises and she was continuously slapped me. When I tried to told them to not to do this act by me, my husband stated beaten up me with shoe, my mother-in-law grabs a lock of my hair and hit me in my head and back and my brother-in-law started kick me. Even they tried to kill me by hung. I beg to them for leave me and anyhow I save myself to lock into the room and next day I called to my father and inform him about this incident. That day My parents came in my matrimonial house and ask my in-laws about this incident, they used filthy languages upon my parents and affront them and drive away them from that place. I tried to go out from that place but they didn't let me go. After that they continuously threatened me to kill me & my child. On

24/07/2025 in apprehension & compulsorily I called to my father to come and taken me from that place. After few hours my mother was came and I requested to my mother to take me into my parental house at Matigara. And in front of my in-laws we go out from that place.

In the meanwhile, after came at parental house my husband have never bothered to come over, instead he have been threatening and slung us over phone that if I lodge any complain against them then he killed us.

On 26/07/2025 in between 8:30p.m to 9:00p.m suddenly my husband came at my parental house intoxicated condition and started slung me, when I ask him to leave from here he slapped me and suddenly hold my throat tightly when I became senseless, my mother save me from his grab and threatened me to kill me anyhow. When my mother started yelled then he run away from my parental house. Hence I have left over with no option other than lodging this written complaint.

In view of the above circumstances I humbly request you to take necessary action against the above name culprits as soon as possible.
