Respected Sir, Madam,

I wish to report a case of house theft that occurred
at my residence, Dy S.P. Uday Tomang, Kazi Man Pradhan Road,
Near Union Bank of India, beside SHED Rehabilitation, Salbari,
Mekibari today, July 28, 2025 between approximately 2:00 AM
and 4:00 AM.

Upon hearing some noise at around 3:50 AM, dogs
barking my mom got up and looked out the window and
saw a man in a white t-shirt approximately of height 5'8" to 5'9" inch. Due to the darkness of the night, his face was
not visible. After hearing my mom's scream he jumped
across the fence from a 1st floor window while other
was down on the ground floor, he jumped across the
wall with a white bag which was little visible.

My mom hurriedly called us after the incident and
we discovered that one of our room wardrobe had been
broken into and several valuable items were stolen.
The entry appears to have been made through puja room
window.
