han Nagar, Dist: Darjeeling wish to report a
severe accident of the Vehicle bearing no.
WB 74 BK 7854 that occurred on 06.06.2025
at around 04:30 am at Salbari Road. The incident
resulted in the tragic death of Nabin Baraily
s/o Anil Baraily of Chamong, Godam Gaon,
Pokhribang, Po: Pokhribang, Ps: Sukhia Pokhri.
