Subject: Lodging of FIR regarding Gold Chain Snatching Incident at Champasari Anchal.

Respected Sir,

I, Smt. Nilam Singh, wife of Shri Bashishta Narayan Singh, residing permanently at Road No. 2, opposite Sri Guru School, Champasari Anchal, P.O. & P.S. – Pradhan Nagar, Siliguri, District – Darjeeling, PIN – 734003, West Bengal, wish to report a gold chain snatching incident that occurred with me on the today morning i.e. **28th July 2025, between 7:00 AM and 7:30 AM.**

While I was standing with my granddaughter near **Paul Aquarium Pet Shop**, close to **Thakur Panchanan Barma Statue**, beside Sri Guru School, Champasari Anchal, two unknown individuals approached us on a motorcycle. One of the individuals suddenly came up from behind and **forcefully snatched my gold chain**, approximately **10 grams in weight**, from around my neck and immediately fled the scene with his accomplice towards **Kalibari, Champasari.**

Some bystanders witnessed the incident and attempted to chase the culprits, but they managed to escape.

I humbly request you to kindly register this complaint as a **First Information Report (FIR)** under the appropriate sections of the Bharatiya Nyaya Sanhita, 2023 related to theft/snatching and initiate necessary investigation for identifying the culprits and recovering my stolen gold chain.

I am ready to cooperate fully with the investigation and provide any additional information required.
