While I was standing with my granddaughter near Paul Aquarium Pet Shop, close to Thakur Panchanan Barma Statue, beside Sri Guru School, Champasari Anchal, two unknown individuals approached us on a motorcycle. One of the individuals suddenly came up from behind and forcefully snatched my gold chain, approximately 10 grams in weight, from around my neck and immediately fled the scene with his accomplice towards Kalibari, Champasari.

Some bystanders witnessed the incident and attempted to chase the culprits, but they managed to escape.
