Mustag TEVEN S/O LL Md Amin Of Koila Depot., W/No. 07, Khalpara, PS_Siliguri, Dist.-Darjeeling which he was holding in hand and (4) One Screw-Driver made of iron measuring about 12" which was recovered from the possession of Md. Mustaq (19 yrs) S/O Lt. Md. Amin Of Koila Depot. , W/No. 07, Khalpara, PS_Siliguri, Dist.-Darjeeling.

I. ASI. Ratan Kr. Ghosh of Panitanki TOP (Under Siliguri PS)/SPC, do hereby lodge this written complaint to the effect that on 29.07.25 at 23.45 hrs. I have received secret source information that 12-15 persons were assembling at the back side of Surya Sen park beside bank of River Mahananda, Mahakai Pally, Siliguri and making preparation to commit decoity at the locality. Accordingly, I conveyed the same to O/C, Panitanki TOP, SPC and as per his direction I have noted the fact in GD book vide Panitanki TOP GDE No. 889 dt. 29.07.25 and as per his direction myself along with ASI. Amal Barman, ASI. Man Mohan Barman, C/233 Nagen Ch. Barman, C/739 Dilip Mitra, C/899 Somnath Roy left for Surya Sen Park beside bank of River Mahananda, Mahakal Pally, Siliguri to verify the veracity of the information. Accordingly, I managed to call two independent witnesses namely (i) Uday Chakraborty S/O Sunil Chakraborty of Dashrath Pally, W/No. 44, PS-Bhaktinagar, Dist.-Darjeeling & (II) Tarun Paul 5/O Ramjay Payl of Bidyachakra Colony, W/No.44, PS-Bhaktinagar, Dist.-Jalpaiguri and request them to accompany with us for search & seizure, if any. Near about 00.15 hrs., myself along with police party & witnesses arrived near Surya Sen Park, Siliguri and kept our vehicle at a reasonable distance and proceed towards bank of River Mahananda behind Surya Sen Park, Siliguri. Upon arrival, being indicated by the source it is found from the considerable distance that a gang of 12-15 persons assembled behind the Surya Sen Park, Siliguri in the bank of River Mahananda, Siliguri and they were whispering in very low voice. Accordingly, we cordoned the place properly and approach towards them. But seeing the presence of police party, they scattered in multi direction and started fleeing away but after a hot chase manage to apprehend 03 (three) persons but others were managed to fled away from the spot. On interrogation, the apprehended persons disclosed their name, address as noted above and started giving incoherent statement regarding their presence/gathering in the same place also. On further grilling they stated that they along with twelve other persons assembled there and making preparation to commit docaity in the locality. Later on being search in presence of the independent witnesses, I have recovered (1) One Javelin measuring 36" (approx) made of Iron from the possession of Dipankar Sarkar (26 yrs) S/O Nirmal Sarkar of Fokdoibari near Kali Mandir, PS-Bhaktinagar, Dist.-Jalpaigur which he was holding on his hand (2) One Sword (sharp cutting weapon) measuring approx 30" including its wooden handle from the possession of Ajay Barman (20 yrs) S/O Lt. Gautam barman Of Koila Depot., W/No. 07, Khalpara, PS-Siliguri, Dist.-Darjeeling which he was holding on his hand (3) One Hammer made of Iron with wooden handle, recovered from the possession of Md. Mustaq (19 yrs) S/O Lt. Md. Amin Of Koila Depot., W/No. 07, Khalpara, PS_Siliguri, Dist.-Darjeeling which he was holding in one hand and (4) One Screw-Driver made of iron measuring about 12" which was recovered from the possession of Md. Mustaq (19 yrs) S/O Lt. Md. Amin Of Koila Depot. , W/No. 07, Khalpara, PS-Siliguri, Dist.-Darjeeling. Accordingly, I seized the above noted recovered articles as per seizure list in between 00.35 hrs. and 00.55 hrs. in presence of the above said witnesses and duly singed by them and then I have arrested the accused persons U/S 35(1) BNSS after explaining each of them about their ground of arrest.

Hence, under the above noted fact and circumstances, I pray that a specific case may kindly be started against (i) Dipankar Sarkar (26 yrs) 5/O Nirmal Sarkar of Fokdoibari near Kali Mandir, PS-Bhaktinagar, Dist.-Jalpaiguri, (ii) Ajay Barman (20 yrs) S/O Lt. Gautam barman Of Koila Depot., W/No. 07, Khalpara, PS_Siliguri, Dist.-Darjeeling and (iii) Md. Mustaq (19 yrs) S/O Lt. Md. Amin Of Koila Depot., W/No. 07, Khalpara, PS_Siliguri, Dist.-Darjeeling and others under proper Section of law and arrange for its investigation.
