Siliguri Police Commission With due respect and humble submission I ASI Sushanta Karmakar of Matigaraes. beg to submit that on 29/07/2025 myself along with force were detailed to perform Mobile Patrol duty, vide C.C. No. 2339/25, Dated 29/07/2025 and GDE No. 1549, Dated 29/07/2025. During my said mobile van duty, I received a source information that one Truck is loaded river bed material Bansbari Ghat, P.S. Matigara and about to start, having no document/Royalty in respect of said load. Accordingly I informed the matter to I/C Matigara P.S., over phone. After hearing the information he directed me to work out over the information at once. Accordingly I along with force rushed to Bansbari Ghat, under Matigara P.S. and found one medium Truck bearing Regn No. WB73D7076 loaded with riverbed materials just started from Bansbari Ghat. I detained the said Truck and on asking the driver of said vehicle could not produce any valid document in respect of said load. It may be presumed that the Driver/Owner of said Truck procured the loaded riverbed materials, illegally and dishonestly, stealing by unfair means from Bansbari Ghat, P.S. - Matigara, for their wrongful gain and trying to proceed to deliver the same to their designated customer.
