- I, Mr. Tenzing Lodoe Bhutia, S/o Late Lobsang Jinpa Bhutia, resident of 43/A, Gundri Bazar, Ward No. 12, Kurseong, P.O. & P.S. Kurseong, Dist. Darjeeling wants to bring it to your kind attention that:
 - That I with Kunsang Chodon Bhutia, W/o Tenzing Lodoe Bhutia, Tsewang Gompo Bhutia, S/o Ngodup Bhutia, Chimé Choedon Bhutia, D/o Tsetan, Tenzin Dechen, D/o Phaduk Sonam Bhutia, are the absolute owners of a piece & parcel of land measuring 3.5 Bighas (approx.) or 116.62 Decimals by way of 05 Sale Deeds bearing Deed Nos. 4617/2012, 265/2012, 262/2012, 263/2012 and 261/2012 all being executed before the A.D.S.R Siliguri-II at Bagdogra.

That on 28/07/2025, certain individuals namely Sunilal Oraon, Vhodo Oraon both sons of Late Bhedla Oraon, Sebni Oraon, W/o Vhodo Oraon, Puspa Oraon, W/o of Sunilal Oraon, Rita Oraon, W/o Podra Oraon, Jhepa Oraon, W/o Kastu Oraon with some other unknown miscreants who are all residents of Patharghata, Uttar Patharghata Gram Panchayat, Opposite Pragati College, Baragharia, Salbari, Dist Darjeeling, unlawfully entered our property without any authority or permission. They forcibly broke open/damaged the boundary and entered the premises.
