Respected Sir,

~~Anurag Majumdar~~ My Snapchat and Instagram were hacked by some hacker by gaining unauthorized access. My private photos and videos were stolen without my consent. The hacker is threatening to leak them using an unknown number and an Instagram id since first week of June 2025.

I strongly suspect an individual who I used to be close friends with. He has emotionally manipulated me before. He threatened me with suicide everytime I tried to break contact with him. When I complained him about the hacking, he manipulated me into believing that I falsely accused him and his accusation led him to commit suicide. He induced his friend to let me know that he has committed suicide and has also left behind a note blaming the suicide on me. His friend threatened me to publish the suicide note and every ^{apparent} false accusation and manipulation I did which led him to suicide.
