Sir,

I, Sri Bijay Lakra, S.E.(E), S&LP Wing, Darjeeling Region, WBSEDCL, Siliguri do here by lodge complaint against Sri Subir Ghosh, S/o- Lt. B.P. Ghosh, Flat No-5a, Block-B, B.P. Plaza, R.R.M. Roy Road, Hakimpara, Ward No-12, P.S.-Siliguri, Dist-Darjeeling for having committed offence as stated here under.

On 31.07.2025 at about 12:48 p.m. acting on a source information I, along with (1) Sri Bhaben Roy, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (2) Sri Biswajit Ghosh, Linesman, Hakimpara CCC and other officials of WBSEDCL entered the residential premises of Sri Subir Ghosh and inspected service installation, metering installation of Consumer ID 412257369 in the name of Sri Subir Ghosh. During inspection it was found that Sri Subir Ghosh is using electricity unauthorisedly & illegally by reconnecting the deemed disconnected service line of the metering installation that was disconnected previously on 05.06.2024 due to non-payment of outstanding energy bill. Total Outstanding dues Rs. 5637.00 (Rupees Five thousand six hundred thirty-seven only) including the LPSC of Rs. 1039.00 (Rupees One thousand thirty-nine only) till the date of 31.07.2025.

As unauthorised reconnection of the disconnected service line and metering installation was detected, the energy meter, make Himachal Energy Pvt Ltd, serial no.- H246000 Rd-51916 installed against Con Id. 412257369, seized by preparing a formal seizure list duly signed by witnesses.

As Sri Subir Ghosh have committed offence u/s 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the disconnected service line, you are requested to take cognizance of the offence by treating this complaint as FIR. The seized articles are packed and labelled by me.
