Sub: FIR In respect to Pilferage of Electricity

Sir/Madam,

I do hereby lodge a complaint empowered by the Electricity Act, 2003, read with further amendments that Mr. Basu Das (User), S/O- Late Gobinda Jiban Das, Address: Rabindra Nagar (Near Shiv More), Ward- 21, Siliguri, P.O.- Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 412023949), has committed Theft of Electricity under section: 135(i) (a) & (b) of the Electricity Act, 2003, read with further amendments, for Domestic purpose as stated below.

On 31.07.2025 at about 20:30 hours, I, Sri Sourav Paul, DE (E) & Station Manager, Subhaspally CCC, WBSEDCL, along with 1. Mr. Bijoy Lakra, SE(E), 2. Mr. Bhaben Roy, Special Officer, attached with S&LP unit, Darjeeling Region Office, WBSEDCL & 2. Mr. Arnab Ray, J.E. (E) (Grade-II) & 3. Mr. Biplab Sarkar, Sr.OE, all attached with Subhaspally CCC, WBSEDCL, entered into the Domestic premises of Late Gobinda Jiban Das, Address: Rabindra Nagar (Near Shiv More), Ward- 21, Siliguri, P.O.- Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 412023949), in order to inspect the service line incoming & leaving the meter as well as Supervisory Checking purpose upon having some confidential information about enjoying electricity at that premises by the unauthorized means.

During inspection, the aforesaid accused, Mr. Basu Das (User), S/O- Late Gobinda Jiban Das, was found consuming Electricity dishonestly in unauthorized manner by Direct Hooking/Tapping by PVC Insulated Copper wire from WBSEDCL's LTOH Network situated in front of the premises & Bypassing the Metering Arrangement by Hooking wire connected directly to the internal wiring arrangement of that domestic premises by separate cut-out arrangement avoiding WBSEDCL's Metering arrangement to run various appliances (e.g. Light, Fan, Refrigerator, TV set, Water Pump etc.) at his aforementioned Domestic premises for Domestic purposes having Accessed/Inspected Load 1.793 KW. Hence the meter was unable to record the proper/exact Electrical Energy consumption. Thus WBSEDCL incurred huge amount of loss in revenue.

As the Theft of Electricity had been detected, I immediately with the help of my Technical staff disconnected his Service Connection as well as the unauthorized connection as per norms and seized One No., PVC Insulated, Black colour, Copper wire, approx. size of 0.55 SQMM & approx. length 2.0 metre along with hooking arrangement jointed with One No., PVC Insulated, Black colour, Copper Wire, approx. size of 1.0 SQMM & approx. Length 1.0 metre jointed with One No., PVC Insulated, Green colour, Copper wire, approx. size of 0.75 SQMM & approx. Length of 1.0 metre jointed with One No., PVC Insulated, White colour, Copper wire, approx. size of 3/20 SWG & approx. Length of 3.0 metre connected with One No. Porcelain Cut-out (make: OSTRON, Rating: 415V, 32A) connected with One No., PVC Insulated, Red colour, Copper Cable, Single Core, approx. size of 10.0 SQMM & approx. Length of 1.0 foot jointed with several PVC Insulated, Copper & Aluminum wires, White, Red & Black colour in some portion, which has been used for Tapping-off Electrical Energy from the WBSEDCL's LTOH Network & Bypassing WBSEDCL's metering arrangement (Meter Serial No: G1417139, Make: Genus, LR: 26147 KWh) by connecting other end of the Tapping/Hooking wire to the house's own wiring arrangement through Cut-out system avoiding WBSEDCL's metering circuit to run various appliances at the aforesaid Domestic premises (Phase line was taken from Hooking wire) under a proper seizure list as well as the seized articles were properly packed, labeled and sealed at the spot after observing necessary formalities in the presence of Inspection Team Members & Witnesses & the Accused Person himself & his local witnesses (i.e. Son etc.). The inspection team members left the aforesaid premises at 22:10 hours on the same day after observing all formalities.

So, the accused, Mr. Basu Das (User), S/O- Late Gobinda Jiban Das, Address: Rabindra Nagar (Near Shiv More), Ward- 21, Siliguri, P.O.- Rabindra Sarani, PS- Siliguri, District- Darjeeling, PIN- 734006 (Consumer ID: 412023949), has committed Theft of Electricity under section: 135(i) (a) & (b) of the Electricity Act, 2003, read with further amendments, for the Domestic purpose.

So I request you to take cognizance against the aforementioned accused person on this matter and consider this complain as FIR to initiate further necessary action from your end.
