With Due Respect I am Devanand Joshi s/o Late Kanhaipal Joshi, Resident of Kainsati Handir Road, Gangs Nagar, SMC Ward No. 5, PO/PS: Siguri Khajpara TOP, would like to inform you that today at around 7:15 am on 21/7/2025, when I returned to my house after performing my Night duty, my Younger Brother Rajesh Joshi s/o Late Kanhaipal Joshi of Kainsati Handir Road, Gangs Nagar has Picked me by Abusing that I am returning home after spending my Night in Red Light Area and when I objected, Rajesh Joshi started assaulting me by fist and blows and wooden bottom and when my Mother aged about 81 yrs tried to save me he & his wife Nand Bulhi caught hold of her & threw her on floor. Due to real sudden assault I sustained serious injury. As it is mentioned that the Rajesh Joshi tried to hit on my head by wooden bottom and when I tried to save my head by my right hand that bottom got hit on my hand resulted my right hand got swelled due to injury. I had been to hospital for treatment of my injuries and I was admitted for X-Ray. The said Rajesh Joshi tried to kill me by hitting on my head by wooden bottom and his wife also co-operated him. So, you are hereby requested to investigate the matter and take necessary legal action against the above-named person.
