In producing herewith 02 (two) arrested accused persons namely (i) Md. Iqbal (31) s/o Lt Md Zahid of Jalmilik PO- Gunjur mani PS Thakurganj Dist Kishanganj Bihar and (ii) Azirul Md. (27) s/o Lt Md. Mofizuddin of Fulbari near Maharaja Hospital, PS New Jalpaiguri Dist Jalpaiguri along with seized articles as mentioned below:.

- One (01) transparent plastic packet containing 101.69 gram said to be brown 1. sugar and marked as "Exhibit A".
- One Scooty bearing registration no BR 37 Y 5814 along with key 2.
- One original D/L in the name Md Iqbal bearing no BR3720230002844 3.
- Cash RS 2980/- in Indian currency from the accused Md. Iqbal. 4.
- Cash RS 280/- in Indian currency from the accused Azirul Md. 5.
- Airtel SIM card having no 9560615848 from the accused Md. Iqbal. 6.
- Airtel SIM card having no 7063082776 and JIO sim card having no 7. 6297028543 from the accused Azirul Md.
- One Android mobile phone REDMI having IMEI No 869009046438298 and 8. 869009046438306 from Azirul Md.
- One Android mobile phone VIVO having IMEI No 864718073660179 and 9. 864718073660161 from Md. Iqbal.

I, SI Tanmay Kundu of New Jalpaiguri PS/SPC do here by lodge this written complaint to the effect that today on 30.07.2024 at about 18:55 hrs, I received an information from my credible source that two persons are illegally carrying with them a huge quantity of brown sugar, a controlled substance under the NDPS Act. They are expected to cross through, cannel road under NJP P.S very soon with the intention of carry the same to Malda for its clandestine disposal and their personal gain. This information suggests a strong likelihood of a cognizable offense under the NDPS Act being committed. If not acted immediately they would succeed to smuggle the same

I reduced the information in writing vide NJP PS GDE No. 1567, dated 30.07.2025 and I intimated the information to you and at about 19:05 hrs myself, along with a team consisting of i. Myself, ii.Sl Samik Paul, iii. ASI Manoj Majumdar, iv. VP 08 Laxman Roy VP 13 Jamirul Islam took departure from New Jalpaiguri PS for Canal road under NJP P.S along with laptop, portable printer, weighing machine, Drug Testing Kits and other necessary documents articles required for operation availing Govt. vehicle to work out the information and the same was diarized vide NJP P.S GDE No. 1568, dated 30.07.2025 and MCC No. 824/2025 dated: 30.07.2025.

At about 19:25 hrs, myself and raid team reached at Canal Road near Dream land restaurant cum Bar area under NJP P.S, and met my source and he briefed me about the detail information. I then looked up for public witnesses and found 02 persons namely: i. Goutam Banik (34) s/o Lt Nikhil Banik of Ghoghomali., Chayan Para, PS Bhaktinagar Dist Jalpaiguri A/P Staff of Greenland Restaurant cum Bar and Biki Singha (25) s/o Khagen Singha of Kharibari PS Kharibari Dist Darjeeling A/P Staff of Greenland Restaurant cum Bar briefed them the information in hand in a nutshell after listening to the information they both voluntarily agreed to stand as witness for the entire process of search and seizure. Thereafter, we ambushed at Canal Road near Dream land restaurant cum Bar area under NJP P.S. and also contacted with videographer namely Tapan Mandal and asked him to came to the spot immediately and make video graphy of whole process of search and seizure if happen.

At about 19:55 hrs, we saw two person was coming from nowa para Side towards fulbari side through canal road with one scooty bearing registration no BR 37 Y 5814. Immediately My source identified them as our suspects accordingly we try to detain them but after seeing police party the scooty rider increase his speed but some how we managed to detain the scooty and above named two persons. We then cordoned them and I introduced myself and the raid team members as Police personal showing our Govt. ID proofs, I then appraised them about the information in hand and started to examine him. During examination, they stated their names as (i) Md. [qbal (31) s/o Lt Md Zahid of Jalmilik PO- Gunjur mani PS Thakurganj Dist Kishanganj Bihar and (ii) Azirul Md. (27) s/o Lt Md. Mofizuddin of Fulbari near Maharaja Hospital, PS New Jalpaiguri Dist Jalpaiguri . I asked them if they had any ID proof they stated that they had no ID proof now. On further questioning, the above noted detainee made contradictory statements at different times but finally he confessed that they were in conscious possession of huge quantities of brown sugar which were packed in sealed plastic packets concealed inside the dikki of the scooty having registration no BR 37 Y 5814 which they were raiding. I then immediately as per provisions of section 50 of the NDPS Act, 1985 (as amended) I explained the above noted 02 detainee and the same was given to him separately in writing stating that he have legal right to tender his personal search in front of a magistrate or a gazetted officer duly empowered under section 42 of the NDPS Act, 1985 (as amended).

I then served Notice U/S 50 of NDPS Act to the 02 detainee whether they were willing to be searched in presence of the police Gazetted officer or any gazetted officer of other department. In reply, they made his written consent to be searched in presence of the Police Gazetted Officer. I then contact to Shri Avijit Dutta, I/C New Jalpaiguri PS for his presence at PO and stand as a gazatted officer.

At about 20:45 hrs, Inspector Shri Avijit Dutta ,I/C New Jalpaiguri PS arrived on the spot and I introduced him as Gazetted officer to the detained persons and the independent witness. I then narrated the development to him in a nutshell.
