On Dated 31.07.2025 Comma No.108090575 CT RAJAN SHARMA Was Detailed To Perform (Evening Op) Op No.05 Bop Fulbari From Bp No-732/4-S To 732/6-S And Bfl.No 15 To 19 , At about 1400 to 1403hrs 05 no of miscreants along with 01 children had been seen going towards Bangladesh from India in the AOR of C coy BOP Fulbari. At about 1401 hrs video footage of C2C at BOP Fulbari shows 02 miscreants coming from Bangladesh side towards India Side. And at about 1403 hrs total 06 miscreants were moving towards Bangladesh side as recorded in D 8 camera (LCTS) on BFL No 16. when area is checked thoroughly it was found that these miscreants have crossed probably by opening the repaired old fence breach joints.
