**Subject:- Written Complaint**

Respected Sir/Madam,

I, Smt. Komal Prasad, W/o Sri Jaideep Gupta, aged about 37 years, presently residing at Tripali Jote-Baniakhari, Opposite Aluminium Factory, Mirik Road, P.O. Nemai, P.S. Matigara, District Darjeeling – 734010, West Bengal, would like to draw your attention towards the following facts against my in-laws namely (1) Sri Jawahar Prasad Gupta (Father-in-Law), S/o Sri Harsh Narayan Gupta (2) Smt. Gita Devi (Mother-in-Law) W/o Sri Jawahar Prasad Gupta (3) Sri Sandip Gupta (Brother-in-Law) S/o Sri Jawahar Prasad Gupta Currently working at abroad now (Dubai) (4) Sri Indranil Gupta (Brother-in-Law) S/o Sri Jawahar Prasad Gupta Currently employed with Indian Railways, posted at Ranchi, and (5) Smt. Puja Gupta (Sister-in-Law), D/o Sri Jawahar Prasad Gupta Currently working as a Government Teacher in Bihar, all are permanent resident of Tripali Jote-Baniakhari, Opp. Aluminium Factory, Mirik Road, P.O. Nemai, P.S. Matigara, District Darjeeling – 734010,.

1. That I got married to Sri Jaideep Gupta on 7th December 2023 at Maya Banquet Hall, Siliguri as per Hindu rites. It was a love-cum-arranged marriage, and all expenses were borne by my parents.
2. That since my marriage my in laws were not happy with me as my marriage was a love marriage and their dream of dowry was not fulfilled because of my marriage and from the beginning of marriage, my mother-in-law (Gita Devi), sister-in-law, and brother-in-laws indirectly pressured me for monetary demands but my husband always supported me.
3. That at the time of our marriage my father has given some household items like sofa set, wooden bed, side table, tea table, LED TV, washing machine, Aqua Guard, geysers, cooler, gold jewellery and cash ₹5,00,000 for house renovation as per the demand of my in-laws. It is pertinent to mention here that all my gold ornaments received as gifts and my cooler were forcibly

- taken away by my mother in law namely Gita Devi in presence of Sandip Gupta (Brother-in-Law).
4. That the greed of my in-laws began to increasing day by day and my father-in-law and mother-in-law further started pressurising me to bring more money from my father but when I informed this to my husband my husband stand alone with my side and rebuke his parents about the same and also support me by saying that I don't need to listened to their demands.
  5. That after some days when my husband was out of the house for his work my in-laws started abusing me in filthy language and placed a demanded of ₹10,00,000 for the marriage of their daughter, else I was asked to leave the house and also threaten me that if this time I informed this to my husband then be ready for dire consequences so i did not inform this to my husband.
  6. That when I did not fulfilled their demand of dowry they started mental and physical torture upon me, in absence of my husband both my in-laws physically assaulted me by pulling my hair and slaping me and when I informed this to my husband my in-laws also started harassing my husband too for money and all..
  7. That upon such harrasment, mental and physical torture when my husband tried to talked to them they again assaulted us and also abused us then I along with my husband went to Matigara Police Station to lodge a written complaint but the officials their asked us to settle the matter between us. Later with the help of Local neighbours and Panchayat intervention we came to a settlement point and upon that settlement, I along with my husband vacated our renovated portion and shifted to the west side of the house peacefully as per a written settlement on 15/11/2024.
  8. That though as per the agreement we have been allowed 60 days time to shift, but the very next day, my in-laws forcibly shifted us from our portion to another side, they locked me inside the west portion against my will, causing mental agony.
  9. That their harassment not stopped and further they stopped our Water supply, electricity, though the bill were paid by us, but it has controlled by my in-laws who switch off the MCB to harass us. Water remains disconnected, and we are barred from using the common well.
  10. That My husband works in a private job earning ₹22,000 per month. I am suffering from(Tumor in Uterus) abdominal health issues this ongoing and these harassment worsens my condition. It is pertinent to mention here that

My only shop (gift and stationery) is our primary livelihood where I have invested ₹4,00,000 but my mother-in-law frequently trespasses in my shop and steal items, cash from my shop, we have photo/video proof of the same.


11. That despite such harassment, we have always provided food, medical care, and other support to my father-in-law, Jawahar Prasad, though he refuses to acknowledge it and insists only on cash help. My father-in-law Jawahar Prasad, despite having a private income, falsely pretends to be neglected. He is a man of questionable character and has twice attempted to outrage my modesty and physically assaulted me inside the house. These immoral acts have deeply traumatized me.


12. That my in-laws has filed a maintenance case before the S.D.M Court and on 24.07.2025 we both appeared before the Ld. Forum and submitted our application but when we back to house then my father in law and mother in law tried to attack us on the way to house, and when we reach at the house they began to abuse us in filthy language and threaten us for dire consequences.

That upon such mental and physical torture, I am praying before your good office to kindly take necessary action against my in-laws laws and save me and my husband from them.

For this I will be very obliged to you.
