With due respect I **SMT. SIKHA SEN** w/o. Samar Sen, resident of, Lenin Sarani- Lower Bhanu Nagar, Sevoke Road SMC. Ward No.43, P.O. Sevoke Road P.S. Bhaktinagar, Dist- Jalpaiguri-734001 West Bengal, would like to inform you that-

That one of my friend named **SRI SANAT GHOSH (KALU)** (accused person) Resident of - Tarapukur Lane Serampore (Opp. Kalika Sweets), P.O Tarapukur & P.S.- Serampore. Dist- Hoogly- West Bengal- PIN- 712203 M-9330812394/ 8910401282 asked me for loan of sum of **Rs.4,00,000/-** ( Rupees four lac ) only for financial help for his business purpose with promise to he will refund the said amount within **6 month** from the date of received of loan money.

And on 22/07/2018 with verbal agreement and friendly relation I had given him loan sum of Rs.4,00,000/- (Rupees four lac) by issuing a post dated Cheque being No.299829 dated 26-07-2018 sum of Rs.4,00,000/- only of Bank of Baroda, Sevoke Road - Siliguri Branch.

The above named accused person Sanat Ghosh (Kalu) had withdrawn the said loan money on 26-07-2018 and kept in his Bank Account. The sum amount he had used for his own purpose and part amount he had fixed deposited in his name at his bank account of Bank of Baroda, Serampur Branch.

That I came to know that the accused person Sanat Ghosh (kalu) had mis-used the said money his own illegal purpose. Though he had not refund the said amount to me within time above noted and /or till date, inspite of several demands by me.

When on 24-06-2025, I asked accused person to return my money he has postponed the several dates to refund of said loan amount to me and also threatened with dire consequences.

The nature and behavior to refund the loan amount is very bad, malafide and motivated intention to cheat my money. As such the accused Sanat Ghosh (kalu) have committed the offence of fraud and cheating with me for his illegal gains and profits.

That the above named accused Person Sanat Ghosh (kalu) have most of the time threatened me with dire consequences and used abusive and filthy languages upon me.

That the above named culprit is very dangerous, antisocial and highly influential persons, he may influence any person and commit the severe offence/s with me.

Therefore, I request you Sir, Please inquire the incidents and after inquiry take necessary action against culprit as per law and save my money and me from his hands.
