## Respected Sir,

I, Soni Khatun, wife of Md. Nayum, resident of Puranabusty, Salbari Bazar, PO. Salbari, PS. Pradhan Nagar, District: Darjeeling, West Bengal, am writing this complaint with extreme distress and urgency against the heinous and life-threatening attack committed on me and my husband by my brother-in-law Alimul Islam, my mother-in-law Noorjahan Khatun & sister-in-law Yasmina Khatun, all are resident of Purana Busty, Salbari, P.O. Sukna, P.S. Pradhan Nagar, Dist. Darjeeling.

There has been a long-standing property dispute between my husband and his brother. In the past, my brother-in-law, Md. Alimul Islam, had already assaulted my husband with deadly intent, for which a specific criminal case stands registered. Since then, he has been repeatedly threatening to kill my husband, seeking opportunities to carry out his threats.

Today i.e. on 01/08/2025 at around 6:30 A.M., My husband left our residence located at Nayabusty, Salbari and proceeded to his under-construction site at Salbari Bazar. While he was on the road, his brother Alimul Islam followed him. As soon as he stopped at the site, he suddenly took out a sharp knife, pointed it at him, and declared he was going to kill my husband.

Without warning, he attacked my husband with the knife. He tried to resist and began screaming and running for safety. He fell on the ground, and as a result his pants were torn and he sustained injuries in his knees. He immediately called me and informed me about the situation. During this chaos, his brother forcibly took the key of scooty of my husband and threw it into a nearby *nala*, deliberately preventing his escape.

Shortly afterward, my mother-in-law Noorjahan Khatun and siste-in-law Yasmina Khatun, who were already present in the nearby area, joined my brother-in-law. They encircled my husband and continued assault him with lathis and bricks. When I reached at the spot, my brother-in-law, mothe-in-law and sister-in-law physically assaulted me using lathis and fists. They pushed me to the ground, causing grave injuries to my head and arms.

While trying to defend himself and me, my husband attempted to snatch the knife away from Alimul, but he kept on attacking my husband with full intention to murder him. When my husband tried to flee, at first, he hurled the knife directly at my husband, but it narrowly missed hitting him, then he began throwing bricks at my husband, one of which hit his head and others at his waist, and back, causing heavy bleeding in his head and grievous injury to his waist, back.

Fearing for our lives, we somehow managed to escape and rushed to District Hospital, Siliguri, for immediate treatment. On the way to hospital he narrated the entire incident to me. He vomited twice on the way to hospital and upon reaching at District Hospital, Siliguri the doctors advised my husband for admission, given the critical condition and seriousness of his head injuries. Presently my husband is admitted in the District Hospital, Siliguri, and is under treatment.

It is very clear that this was a planned and premeditated attempt to murder my husband, jointly carried out by Alimul Islam, Noorjahan Khatun, and Yasmina Khatun. They have been conspiring to eliminate him for a long time, and today, taking advantage of the early hour and the absence of public, they attempted to execute their plan.

Therefore, I earnestly request you to initiate an immediate and thorough investigation into the matter, and take stringent legal action against the above-named individuals to ensure that justice is served.
