I became the absolute and exclusive owner of an area of land measuring 0.17 acre situated within Mouza Mandlaguri, under Khatian No. 46, Plot No. 100 by virtue of my purchase from Mulu Oraon (son of Late Bifaiya Oraon of Champasari, Siliguri) vide **Deed of Conveyance No. 5805 for the year 1988** executed by him which was registered in the office of the Sub-Registrar, Siliguri upon obtaining necessary permission from the Scheduled Castes & Tribes Welfare Officer & R.O. under Chapter IIA of the W.B.L.R. Act, Siliguri and the actual, khas and physical possession of the said land has been delivered to me by my said vendor. I have permanent, heritable and transferable right, title and interest in the said land, being the true and lawful owner thereof.

My wife, **SANTA PAUL** became the absolute and exclusive owner of an area of land measuring 0.17 acre situated within Mouza Mandlaguri, under Khatian No. 46, Plot No. 100 by virtue of her purchase from Mulu Oraon (son of Late Bifaiya Oraon of Champasari, Siliguri) vide **Deed of Conveyance No. 5806 for the year 1988** executed by him which was registered in the office of the Sub-Registrar, Siliguri upon obtaining necessary permission from the Scheduled Castes & Tribes Welfare Officer & R.O. under Chapter IIA of the W.B.L.R. Act, Siliguri and the actual, khas and physical possession of the said land has been delivered to my wife by her said vendor. Santa Paul has permanent, heritable and transferable right, title and interest in the said land, being the true and lawful owner thereof.

Under the circumstances, I would, most humbly request you to kindly inquire into the matter and take appropriate legal action against the said persons for their illegal and oppressive acts and to protect our land from being illegally grabbed by the miscreants.

I am ready and willing to submit before you all the necessary documents of title in respect of the aforesaid land owned by me and my wife, Santa Paul.
