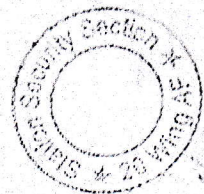

HANDED OVER SUSPECTIOUS CIVILIAN

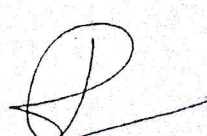
Sir,
