Respected Sir,

I, Smt. Passang Lhamu @ Passang Lhamu Tamang, W/o Shyam Singh Tamang, resident of Burtuk, Gangtok, East Sikkim, would like to inform you that unfortunate and distressing conduct of one Smt. Tanushree Karmakar, Advocate, and member of Siliguri Bar Association.

I had engaged Smt. Tanushree Karmakar to carry out the registration of a Sale Deed in my favour in respect of a land at A.D.S.R. Siliguri II, Bagdogra. As per her instructions, I was informed that the total government assessed value of the land was Rs. 59,40,000/-(Rupees Fifty-Nine Lakhs Forty Thousand only), and for registration purposes, I was to pay a total sum of Rs. 4,36,400/- (Rupees Four Lakhs Thirty-Six Thousand Four Hundred only), which included the registration fee of Rs. 4,26,400/- and professional and office fee of Rs. 10,000/-.

Accordingly, I made the following payments to her:

- 1. Rs. 3,06,400/- via Account Transfer to her A/C No. 32040820654
- 30,000/- via Phone Pay transfer 2. Rs.
- 3. Rs. 1,00,000/- in cash, handed over personally

Thus, I have paid a total of Rs. 4,36,400/- (Rupees Four Lakhs Thirty-Six Thousand Four Hundred only).

However, to my utter shock and dismay, on 07.03.2025, when the registration was completed and after few days when I received the executed Deed, I found that it was not a The legistration was singurable stated and after new days when I received the executed Deed, I found that it was not a to know that the Advocate had only paid Rs. 60.400/- i.e. (Re. 50.400/ to know that the Advocate had only paid Rs. 60,400/- i.e (Rs. 59,400/- as registration fee and Rs. 1,000/- as Stamp duty) to the Government, despite collecting Rs. 4,36,400/- from me.

> I immediately raised the issue with Smt. Tanushree Karmakar, and she assured me that she would execute a fresh Sale Deed in my favour. However, since then, she has only been delaying the matter and avoiding all communication. Despite several requests, she has not refunded the remaining sum of Rs. 3,66,000/- nor taken steps to rectify the error or complete the sale registration properly.

> What is even more alarming is that she has started threatening me with false cases, asserting her status as an Advocate and claiming that no action can be taken against her.

> I formally reported this matter on 14.07.2025 to the Secretary of Siliguri Bar Association, but no settlement or redressal has taken place as she failed to appear or respond.

> > Chank you.

I am deeply aggrieved by this betrayal of trust, misconduct, and exploitation. Her conduct amounts to criminal breach of trust, cheating, and professional misconduct, which is unbecoming of a legal profession ethics.

I, therefore, most respectfully request you to kindly take necessary legal action against Smt. Tanushree Karmakar, Advocate, I shall remain ever grateful for your prompt attention and kind cooperation in this matter.
