With due respect I Sanam Munda, S/o Lt. Jhuran Munda, resident of Moonee Tea Garden, PS- Bagdogra, Darjeeling, do hereby lodged this complaint with the information that on dt. 28/07/2025 at about 01:45 AM, while my brother Badal Mandal and his two friend namely Amardeep Nagesia, S/o Bana Nagesia and Eithas Munda, S/o Lt. Robin Munda, of the same locality who was returning home from Ghospukur by a motorcycle bearing no. WB74AZ6591, after attending a family program and while they reached near Gangaram Army Camp 46, one four wheeler dashed their motorcycle by rash and negligent driving resulting in my brother and and his two friends sustained grievous injuries on their person, the local people took him to NBMC & Hospital, Siliguri, where attended Dr. declared my brother and said Amardeep Nagesia brought dead and another victim i.e Eithas Munda was admitted there for medical care.

My brother's post mortem was done at NBMC & Hospital, Siliguri, asper Matigara PS UD Case no. 860/25, and Amardeep Magesia Post Mortem done as per Matigara PS UD case no. 859/25, dt. 28/07/2025.

Hence today I am submitting my written complaint to you with a request to take legal action against the driver of the said offending vehicle.
