That, today 6 o'clock in the evening person namely, the main assaulters namely ① Sabita Thakur, w/o Jitendra Thakur, ② Barsha Thakur, d/o Jitendra Thakur, ③ Jitendra Thakur, h/o Sabita Thakur, ④ Gopintha Hazra, s/o Tinku Hazra, ⑤ Mother of Jitendra Thakur, w/o Shanti Nagar, Airport more, attacked me with my family in which, we got seriously injured and hurt. That these culprits, fled us with stones and other weapons like rod (stick), and threatened us to be killed and also slanged us. That, in this attack they also took away a gold chain from my husband neck and hit us continuously with stones.

That, this kind of behaviour is anti social and criminal and we are threatened of our life. Sir kindly do the needful.
