I, MD RAZI AHMAD WANTS TO BRING TO YOUR NOTICE THAT EVEN AFTER SEVERAL COMPLAIN TO THE COMMISSIONER OFFICE AND MAS PETITION ATTACHED WITH THE FIR AGAINST MD SALAM, MD KALAM, MD KALIM (SON OF LATE MD HANIF), MD AJMAT AND HIS NEPHEW (CHOTU) AND HIS BROTHER IN LAW HAIDER AND OTHER RELATIVES, FOR THEIR EARLIER MISCHIEF YET THEY HAD ATTACKED MY SON MD SHADAB RIZVI CAUSING HIS HEAD BURST AND ALONG WITH MD SHADAB RIZVI MY NEPHEW MD NADEEM FURKAN HAD ALSO BEEN A VICTIM OF THEIR ATTACK AND HE HAD BEEN HOSPITALIZED DUE TO HEAD BURST AND EXTENSIVE BLOOD LOSS, THEY HAD ATTACKED WITH IRON ROD, HOCKEY STICK, SWORD ETC IN VENUS MORE NEAR JAMA MASJID.
