with iron rod, wooden stick, hockey
stick and iron sword (talwar),
at that moment brother-in-law of
Salam namely Razi Haider was
there at the shop, then they attacked
Haider and chopped his head with
a sword, he was bleeding from his
head and became senseless, then
assaulted us with the intention to kill
then they ransacked the cash box
and the shop and left, Haider is
now admitted at Siliguri Hospital, he got
6 stitches on his head.
