**Subject: FIR regarding road accident and injury caused by vehicle WB73L3948 driven by Abdul Raja on 19/07/2025 at Jalpai More, Siliguri**

Respected Sir

I, Partha Mandal, S/O Chittaranjan Mandal, resident of Netaji Colony, Ward no. 37, Ghogomali, Siliguri, West Bengal, PIN- 734006. would like to lodge an official complaint regarding a road accident that occurred on 19th July 2025 at approximately 4:30 PM at Jalpai More, Siliguri.

On the said date and time, a white commercial vehicle, Tata Intra V30 bearing registration number WB73L3948, came at high speed and from the wrong side, recklessly hitting my two-wheeler, a TVS Ntorq 125 (Registration No. WB74BL8826) along with another two-wheeler Honda Shine (Registration No. WB34BA6828). The vehicle was being driven by Abdul Raja, a resident of Shanti Para, Siliguri, Aadhaar No. 8245 5899 1648, Mobile: 9679452343.

Due to the collision, my scooter was severely damaged (approximate repair cost Rs. 30,000) and I sustained injuries, for which I was taken to Siliguri District Hospital for medical attention. A copy of my medical slip has been enclosed herewith.

Immediately after the accident, the driver, Abdul Raja, admitted fault and requested me not to lodge a police complaint, assuring full compensation for damages. However, since then, he has turned unresponsive and his mobile phone is switched off.

This incident has caused me physical injury, financial loss, and mental trauma. It is clear that the act was intentional and negligent, and I now seek police intervention to initiate appropriate legal action against the offender.

I kindly request you to register this complaint as an FIR and take immediate necessary action against the accused, Abdul Raja, under relevant sections of law.
