Subject: Intimation regarding damage of HT pole by vehicle (WB 85 0420)

Respected Sir,

On 03.08.2025 around 06:30AM, damage of one double pole structure has been reported from Naukaghat, near Biswabangla Hat area, Kawakhali by maintenance gang while patrolling for the cause of breakdown of Porajhar 11KV feeder emanated from Kawakhali 33/11KV Sub-Station under Siliguri Sub-Urban Division. After checking by maintenance gang it has been gathered that the structure was damaged by a vehicle, numbered WB 85 0420 (Pictures of site and vehicle number attached). Because of this damage WBSEDCL has to bare repair maintenance cost of Rs. 86,559.00 for restoring the power system.

Thus it is requested to enquire this matter as your intervention is needed in this matter. Attached to this letter are copies photographs of the scene and vehicle. We hope that these will aid in your initial assessments. We would appreciate it if you could keep us informed about the progress of your investigation and any assistance you might need from our side. Thank you.
