**Sub:- First Information Report**

Respected Sir,

I, the undersigned would like to bring your kind attention towards the fact that on 21.03.2025 I got married to one Zahir Sekh, Son of Zabbas Sekh, resident of Rajaholi, Ward No. 35 under S.M.C., Siliguri, P.O. – Bhaktinagar, P.S. – N.J.P., District – Jalpaiguri, Pin – 734007 according to the Muslim rites and rituals by way of Nikah Nama at my parental house situated at Bagmara, P.O. & P.S. - Thakurganj, District – Kishanganj, Bihar. At the time of marriage my father alongwith other relatives have given a sum of Rs. 1,20,000/- (Rupees One Lakh Twenty Thousand only) in cash alongwith gold ornaments which weighs about 06 grams (Ear Rings, Nose Pin), Silver Ornaments which weighs about 25 grams (10 Finger Rings, 01 Chain, 02 Bangles, One pair of anklet), Steel Bed, Showcase, Alna, Trunk, Dining Table, Kitchen Utensils, Mixer Grinder, Garments and other gifts as per the demand of the said Zahir Sekh and his parents namely, Jabbas Sekh (Father) and Saliya Khatoon (Mother) as dowry.

I would like to further state that after the solemnization of the marriage said Zahir Sekh brought me in his aforementioned house and we started our conjugal life under same roof as a joint mess with his parents. That in the beginning the attitude of my husband and in-law towards me was good. But after passing of time their attitude towards me started to change and they started to abuse me with their taunts and if I would protest then they used to abuse me with filthy languages which cannot be uttered in the civilized society and in many occasions they have also not hesitated to slap me and raise their hands in any way possible to cause physical harm to me.

I would like to further inform you that my husband is an addict and he is in regular habit of consuming Brown Sugar and used to ask money from me or to ask money from my parents and whenever I denied to do so my husband used to beat me almost every night.



I would like to further inform you that on 27.07.2025 a lady (Saraswati Mahato) came to the house of my in-laws alongwith an infant baby boy aged around 2 years carrying in her lap and claimed herself that she is the wife of my husband and the baby was my husband's child. Seeing that lady I asked to my husband and in-laws about that lady and the child. After my enquiry I was informed by my in-laws that the said women is the first wife of my husband and the child is my husband's own son which they have concealed from me during my marriage with said Zahir Sekh. After I protested about this they have beaten me ruthlessly and have thrashed me mercilessly. Moreover, I am a pregnant woman and my in-laws and husband have kicked me in my belly I could not take such pain and have fainted for a while and when I regained my senses I found that my mother in law was sitting upon my belly and was trying to cause miscarriage of my unborn child and when I screamed for help she choked my neck and tried to kill me. It is further mentioned that my mother in law always used to beat me after hearing about my pregnancy and used to force me on getting an abortion.

I would like to further state that somehow after the intervention of the local neighbours I was saved by life and after that I called my family members to rescue me from such dangerous peoples.

Under the above circumstances I would like to request your good officer to investigate the said matter for the ends of justice.
