Subject: Complaint against **Mr. Saurav Chaurasia** for wrongful sexual intercourse under false promise of marriage, exploitation, threats, and criminal intimidation.

Respected Sir/Madam,

I, **Rapti Baidya**, aged about 23 years, daughter of Shri Parimal Baidya, and presently a medical aspirant, residing at **Deshbandhupara, A.P.C. Sarani, Ward No. 33, Siliguri – 734004**, wish to formally lodge this complaint regarding a deeply traumatic and exploitative situation that I have been subjected to over the past year at the hands of one **Mr. Saurav Chaurasia, son of Shri Om Chaurasia, a resident of Premsadan, near Tamanna Factory, Ward No. 41, Bankim Nagar, Siliguri – 734001**.

I came into contact with the said Saurav Chaurasia in or around **June 2024 through Facebook**, where he initially messaged me and continued to pursue me persistently. He would frequently flatter and emotionally manipulate me, insisting on meeting in person. Eventually, we met, and over time he projected himself as a committed and trustworthy individual with genuine intentions. Through repeated expressions of love and persistent persuasion, he eventually proposed marriage to me. Emotionally invested and convinced of his sincerity, I placed my complete trust in him and began planning a future with him.

On the basis of this repeated and solemn assurance of marriage, I agreed to engage in a physical relationship with him. **He deliberately took me to various hotels in siliguri on multiple occasions for the sole purpose of engaging in sexual intercourse and also coerced me into physical relations at my own residence ie home, during times when my parents were not present, all under the false assurance of marriage.**

Each time, he reassured me verbally that marriage was certain and forthcoming, and that I should consider him as my life partner. At no point did I imagine that his intentions were anything other than sincere. In fact, to further cement his false promises, he even arranged a formal engagement ceremony on **15th November 2024**, attended by some of his relatives and acquaintances, which convinced me — and others — of his commitment to me. I now realize that this too was a calculated and fraudulent act, staged merely to exploit me emotionally and physically under the garb of social legitimacy.

However, as time passed, his behaviour drastically changed. He began distancing himself, ignoring my calls and messages, and acting cold and evasive. When I questioned his intentions and reminded him of his promises, he became aggressive, dismissive, and eventually denied everything. To my utter shock and devastation, I later discovered that he had also disclosed personal and intimate details of our relationship to some of my friends and acquaintances, thereby publicly humiliating me and tarnishing my dignity. I am suffering from extreme emotional distress, mental agony, and social stigma as a result of this betrayal and defamation.

When I confronted him and warned him of legal consequences, he threatened me with dire consequences. He clearly told me that if I ever revealed the truth or took any legal step, he would ensure I would “regret it” and be “taught a lesson.” His threats have left me shaken and terrified. I have also come to know that several of his close friends and associates in the locality are individuals with criminal backgrounds, and their recent behaviour — including stalking me near my residence and coaching centre — has made me feel unsafe and extremely vulnerable. I am genuinely afraid that he, with the help of these individuals, might attempt to harm me or my family to silence me and prevent me from taking further steps.

It is now completely clear to me that Mr. Saurav Chaurasia never intended to marry me, and all his actions — from online manipulation to the sham engagement — were carefully orchestrated with the sole purpose of luring me into a physical relationship under false pretenses. This was a gross violation of my trust and dignity, and has caused irreparable damage to my emotional and psychological well-being.

I, therefore, most humbly request you to immediately take cognizance of this matter, register a formal FIR, and initiate a thorough investigation against Mr. Saurav Chaurasia and his associates. I am prepared to submit all relevant evidence including messages, photos, hotel records, and details of

the engagement function, and to assist in the investigation. I also earnestly request that necessary protection be granted to me and my family, as I am living in constant fear for our safety.

Please treat this complaint as urgent and take appropriate legal action at the earliest.


