Subject: Prayer for taking immediate legal action against the accused persons for kidnapping, assault, and attempted murder of my minor son

Respected Sir,

I, **Smt. Sabita Barman**, wife of Sri Bomkesh Barman, permanent resident of Fairani Jote, P.O. Ranidanga, P.S. – Bagdogra, District - Darjeeling, do hereby most respectfully state with deep sorrow that yesterday i.e. 29/07/2025 at around 10:30 AM, my minor son, **Shri Rahul Barman** (aged 14 years), went to school as per his daily routine. However, at around 3:02 PM, we received a phone call from mobile number 7029403922 informing us that my son was found unconscious with multiple injuries and bruises all over his body, lying in an isolated and deserted area inside a tea garden near Chhota Rajajhar.

**Upon receiving the information, we immediately rushed to the said place and found my son in a near-death condition with visible injuries.** We promptly took him to North Bengal Medical College and Hospital, where he was admitted for emergency treatment. At around 9:00 PM the same day, after regaining consciousness, my son disclosed that two individuals from our neighborhood, namely: **1) Sri Rohit Barman**, son of Sri Ashutosh Barman, **2. Sri Hrithik Barman**, son of Nirjan Barman, both are residents of Fairani Jote, P.O. Ranidanga, P.S. – Bagdogra, District – Darjeeling had abducted him on his way to school, forcibly picked him up in a vehicle, and took him to a riverside jungle near MM Terai (Bengdubi area). **There, they forcefully made him consume intoxicating and poisonous substances, after which they brutally beat him, attempted to strangle him to death by throttling, and assaulted him all over his body using tree branches, causing serious injuries.** Thinking that he was dead, they dumped his body in the aforementioned deserted tea garden at Chhota Rajajhar and fled the scene.

It is pertinent to mention here that my minor son had only conversed with the minor daughter of accused Sri Rohit Barman, which seemingly provoked the accused persons to commit such a heinous and inhumane act, attempting to murder a 14-year-old boy.

Therefore, I earnestly request you to kindly take immediate and stringent legal action against the above-named accused persons by arresting them at the earliest and initiating proper proceedings as per law.
