Subject: Filing of Complaint Against Employees and Agents of Sundaram Finance for Illegal Seizure, Criminal Intimidation, and Extortion

Respected Sir/Madam,

I, Arjun Chettri, son of Bal Bahadur Chettri, resident of Mamkhola Forest Busty, Rongpo, Kalimpong, District Darjeeling, West Bengal, am the lawful owner of a vehicle bearing registration number WB785577. I hereby wish to lodge a formal complaint regarding a serious incident involving illegal and forcible repossession of my vehicle, along with acts of criminal intimidation, abuse, extortion, and theft by individuals claiming to be employees, agents, and the manager of Sundaram Finance.

In the month of 31/07/2025, while I had parked my vehicle at Eastern bypass, Madal Petrol Pump to have lunch, a group of unknown individuals, including agents and representatives of Sundaram Finance, along with their manager, forcibly took possession of my vehicle without serving any prior notice, intimation, or following due legal process. During this unlawful seizure, I was publicly harassed, physically threatened, and abused with obscene and filthy language. The said persons used manpower and physical force against me to wrongfully seize the vehicle, despite my strong objections.

I categorically state that there was no outstanding loan due with Sundaram Finance in respect of the said vehicle at the time of this incident. The entire loan amount had already been repaid in full and no dues were pending.

After the incident, when I contacted the Manager of Sundaram Finance Raju Roy and Others, I was shocked to be illegally asked to pay an arbitrary sum of money for the release of my own vehicle. Further, they refused to disclose the location where my vehicle had been taken.

Moreover, a sum of approximately ₹25.000/- in cash was inside the vehicle at the time of its illegal repossession, which is now missing. I have not been given any acknowledgment, seizure receipt, or documentation in relation to the taking of my vehicle or the cash it contained.

The actions of the above-mentioned persons amount to serious cognizable offences under the Bharatiya Nyaya Sanhita, 2023, including but not limited to Theft, Extortion, Criminal Intimidation, Cheating, Criminal Trespass and Misappropriation of Property, Illegal Use of Force and Harassment

These acts have caused me severe mental distress, humiliation, and financial loss.

I humbly request you to Register an FIR under the relevant provisions of the Bharatiya Nyaya Sanhita, 2023 against the concerned employees, agents, and manager of Sundaram Finance, Immediately trace and recover my vehicle bearing registration number WB785577, Investigate and recover the missing ₹25,000/- which was inside the vehicle at the time, Initiate appropriate legal action against all persons involved in this unlawful and criminal act.

I am ready to provide any further documents, evidence, or assistance required for the investigation.
