Sir

In producing herewith following four accused persons namely (1) Gopal Das (23yrs) S/O Kashi Das of Bashjhar more, Iskon Mondir road, W/N 40, Ps Bhaktinagar, Dist Jalpaiguri. (2) Md Bapi Alam (34) S/O Lt Md Jalil Hoque of Durganagar more, near Khichuripatty, W/N 40, PS Bhaktinagar, Dist Jalpaiguri. (3) Sukumar Roy (34yrs) S/O Lt Seben Roy of Bidyasagar Sagar Sarani, near iscon Mondir, durganagar, Ps Bhaktinagar, Dist Jalpaiguri. (4) Rohit Sewa (25) S/O Bimal Sewa of Kholachand Fafri, near Krishna Mandir, Ps Bhaktinagar, Dist Jalpaiguri. With following seized articles viz:

- 1) One iron knife measuring approx 9 inches in length recovered from the exclusive and conscious possession of Gopal Das.
- 2) One iron made Wrench approx 06 inches in length recovered from the exclusive and conscious possession of Md Bapi Alam.
- 3) One iron made screw driver about 9 inches with plastic but recovered from the exclusive and conscious possession of Sukumar Roy.
- 4) One iron road, approx 03 fit recovered from the exclusive and conscious possession of Rohit Sewa.

I, ASI Dhruba Misra S/O Abani Misra of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted persons namely Gopal Das (23yrs) S/O Kashi Das 2) Md Bapi Alam (34) S/O Lt Md Jalil Hoque. 3) Sukumar Roy (34yrs) S/O Lt Seben Roy. 4) Rohit Sewa (25) S/O Bimal Sewa and 6/7 others to the effect that on 06.08.24 at 00:45 hrs received a specific source information that 10/11 miscreants have assembled at Bangla Bazar, Roy colony under Bhaktinagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Bhaktinagar PS and diarized the fact in General diary vide Bhaktinagar PS GDE No 243 dated 06.08.2025 and as per order I along with SI Laksang Bhutia, ASI Sailesh Das, C/560 Ashok Oraon, C/1435 Bikash Barman and C/1431 Dilip Barman & C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for Bangla Bazar, Roy colony under Bhaktinagar PS, to work out the information in hand. At about 00.55 hrs we arrived at Bangla Bazar, Roy colony under Bhaktinagar PS, as indicated by the source we noticed that 10/11 persons were assembled there and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after somehow we managed to apprehended above noted 04 (four) of them with deadly weapons from their exclusive and conscious possession but 6/7 persons managed to fled away from the spot taking the advantage of darkness and open place.

On interrogation the apprehended accused persons disclosed their name and identity as noted above and also stated that they were present there and making preparation for

committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession. On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest the whole search seizure was made on 06.08.2025 in between 01.10 hrs to 01.50 hrs. The whole process of search and seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 04 (four) arrested accused persons namely (1) Gopal Das (23yrs) S/O Kashi Das of Bashjhar more, Iskon Mondir road, W/N 40, Ps Bhaktinagar, Dist Jalpaiguri. (2) Md Bapi Alam (34) S/O Lt Md Jalil Hoque of Durganagar more, near Khichuripatty, W/N 40, PS Bhaktinagar, Dist Jalpaiguri. (3) Sukumar Roy (34yrs) S/O Lt Seben Roy of Bidyasagar Sagar Sarani, near iscon Mondir, Durganagar, Ps Bhaktinagar, Dist Jalpaiguri. (4) Rohit Sewa (25) S/O Bimal Sewa of Kholachand Fafri, near Krishna Mandir, Ps Bhaktinagar, Dist Jalpaiguri and 6/7 others kindly arrange for its investigation
