

In producing herewith three arrested person namely 1) Ashutosh Biswas-31 yrs s/o Gopeswar Biswas of Chilkir hat, PS Kotwali Dist Cooch bihar at present house of Kamal chandra paul of Sastrinagar, Green park, ward no.41 PS Bhaktinagar Dist Jalpaiguri (not verified), 2) Uttam Sarkar-33yrs s/o Chittaranjan Biswas of vill Karial patnipara PS Gangarampur dist Dakshin Dinajpur c/o Prasenjit sarkar Bhalobasa more Dewniapara PS NJP/Jalpaiguri (not verified), 3) Ujjal Sarkar-27 yrs s/o Ukil Sarkar of Nandanpur, PS Gangarampur/Dakshin Dinajpur (not verified) along with the following seized articles under seizure as per seizure list:

One Mint Colour vivo Y56 mobile having IMEI no 867492066694994, connecting (v) no 7319505693.

One Black & Blue Colour vivo mobile having IMEI no 860586050727657, (vi) connecting no 9883685172.

In total 17.01 kg Said to be Ganja has been recovered & Seized.

I, SI Youel lepcha S/O Jai Tshering Lepcha of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above mentioned accused persons to the effect that on 05.08.2025 at about 22.10hrs, received a reliable source input that one Ashutosh Biswas tenant of Kamal Ch Paul is storing and selling said to be Ganja from his rented house which is located at Sastrinagar, Green park, ward no.41 PS Bhaktinagar Dist Jalpaiguri. The matter was diarized in Bhaktinagar PS vide Bhaktinagar PS GDE No. 238/25 dated 05.08.2025 and subsequently, I informed the matter in written to the I/C Bhaktinagar PS, SPC and being directed, at about 22.25hrs I along with SI Srimanta Chatterjee, ASI Khagen Barman, ASI Dipak Karmakar and Const/374 Debraj Biswas left PS by govt. hired vehicle to verify the veracity of the information. This refers to Bhaktinagar PS GDE no. 239/25 dated 05.08.2025 and M.C.C No-3921/25 Dated 05.08.2025

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter, at about 22.55hrs, we reached Sastrinagar, Green park, ward no.41under Bhaktinagar PS, and after arriving there, I found the public there at the spot, and I tried to convince them to accompany us. The following persons, namely 1) Jaganath Roy(49 years S/O Lt Gopinath Roy of Dhupguri Roy Para ward no 2, PS Dhupguri, Dist Jalpaiguri A/P Tenant of Kamal Ch Paul of Sastrinagar, Green park, ward no.41, under Bhaktinagar PS. 2) Kanai Roy (27 years) S/O Goutam Roy of Krishna nagar near BHavesh Petrol pump PS Bhaktinagar Dist Jalpaiguri, A/P tenant of Kamal Ch Paul of Sastrinagar, Green park, ward no.41 came forward to accompany us to work out the information.

Thereafter i informed them about the information in hand and requested them in writing to accompany us in the whole process during search and seizure, if any and they gave in writing about their approval to accompany Police during raid, search and seizure. Being indicated by the source and in the presence of independent witnesses, I knocked on the door of Ashutosh Biswas. When the door was opened by one person, we discovered three individuals present in the room. We detained them, identified ourselves, and shared the information we had. We informed them that they would be searched as individuals, as well as their room, for this purpose. At this, they disclosing their name and address as noted above. Further they confessed that they have possessed the Ganja for supplying the same to their designed customers as per requirement. I then gave them option whether they wanted to be secret. to be searched in presence of the special Executive Magistrate or by any Gazetted Officer.

Then they are a notice in Then they agreed to be searched by one of them. Further I served them a notice in accordance with accordance with provisions of law in this regards.

Subsequently, being demanded in presence of Shri Amit Adhikary Inspector In-Charge, Gazette Police Officer the detained persons failed to produce any valid document in support of aforesaid recovered said to be Ganja.

I seized the aforementioned articles at the location, and a proper seizure list was prepared by me and duly signed by independent witnesses. I labeled and sealed the items, and the entire search and seizure operation was conducted under the supervision of Shri Amit Adhikary, Inspector In-Charge of Bhaktinagar Police Station. The entire process of search and seizure was captured in audio and video recordings. The entire procedure of search & Seizure seizure took place on 06.08.2025 from 00:05 hrs to 01:45 hrs.

Upon further questioning, the apprehended individual admitted in the presence of Shri Amit Adhikary, Inspector In-Charge of Bhaktinagar Police Station, and other witnesses that they secretly procured Ganja from the Coochbehar area with the intention of selling it at a high price to their designated customers for personal profit. They also disclosed that they had been engaging in the illegal procurement and sale of Ganja for the past few months.

Then, I arrested the above noted accused persons after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest u/s 35 of BNSS.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely 1) Ashutosh Biswas 2) Uttam Sarkar, 3) Ujjal Sarkar and arrange for its investigation.

Inspector fri-Charge Bhaktinagar Police Station Siligeri Police Commissionerate committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession. On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest the whole search seizure was made on 06.082025 in between 01.10 hrs to 01.50 hrs. The whole process of search and seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 04 (four) arrested accused persons namely (1) Gopal Das (23yrs) S/O Kashi Das of Bashjhar more, Iskon Mondir road, W/N 40, Ps Bhaktinagar, Dist Jalpaiguri. (2) Md Bapi Alam (34) S/O Lt Md Jalil Hoque of Durganagar more, near Khichuripatty, W/N 40, PS Bhaktinagar, Dist Jalpaiguri. (3) Sukumar Roy (34yrs) S/O Lt Seben Roy of Bidyasagar Sagar Sarani, near iscon Mondir, Durganagar, Ps Bhaktinagar, Dist Jalpaiguri.
