While coming from my duty at night I have been attacked by some miscreants known as Ranjan Thapa, son of Dhani Kumar Thapa of Odlabari, Toribari (Limbu Busty) P.O. Odlabari, Jalpaiguri, West Bengal with his unknown friend. He is working at Salugara in Appa Hotel as I know from the reliable sources. Due to unknown facts he attacked me all of sudden near by my residence located at behind Vega Circle, Siliguri. I had been badly injured and my head was badly wounded by sharp knife. The incident took place during the night at around 1:30 AM on 31st July,2025. After the incident they run away from the spot and I called at 100 to Police to save my life. I rescued myself from street and Police took up me to the Siliguri District Hospital and I was admitted. Now I am under treatment and my head is badly injured.

Therefore, I request you to kindly enquire the matter and I appeal to take necessary action against the attack on my life and attempted murder, so that the miscreants could be punished as per the law and order through your immediate action please.
