I, the undersigned would like to inform you that I had acquired the physical possession (rest land) of a temporary structure measuring about 13 ft X 15 ft. with C.I. Sheet roofing bearing Holding No. 296/254/590/112 situated in the Ward No. 5 of Siliguri Municipal Corporation from its previous possession holder Sri Bhagwan Pandey, Son of Late Uttam Pandey on 27.00.2000 against the consideration of a sum of Rs. 15,000/- (Rupees Fifteen Thousand only) and at the time of taking the physical possession of the said land and structure, I alongwith said Bhagwan Pandey had entered into an agreement on 27.06.2000 in the presence of the neighbours of the said locality.

I would like to further inform you that the said area where my land and shop room is situated is popularly known as 'Santoshi Nagar'. The said entire Santoshi Nagar had been setup and established its infrastructure like pucca road, electricity, drainage system, drinking water facilities, etc. in and over the chunk of vest land of permanent nature and character for the welfare and better livelihood of the permanent occupants and the local people of the said locality and moreover since a long the temples and religious institution popularly known as 'Khatu Shyam Mandir', 'Salasar Mandir', 'Ganesh Mandir' and 'Santoshi Mandir' had been established which attract lakhs of devotees from across the State of West Bengal and those temples are also built in and over the said vest land. There are more than 1,00,000 (One Lakh) co-habitants who had/have been residing since a long and most of the co-habitants had/have been earning their livelihood and residing therein.

I would like to further inform you that after taking the physical possession, I had constructed a two storied building in the year of 2000 consisting of one room measuring about 10 ft, x 15 ft. in each floor and after completion of the

said construction work I had started to run a stationery shop in the ground floor and started to use the first floor for the residential purpose of my family members including my children. The said construction work had been done with the permission and consent of the then elected councilor Sri Ashok Bhagat.

I would like to further inform you that I had obtained the Trade License duly issued by Siliguri Municipal Corporation for running my said stationary shop under the name and style 'Rajen General Stores' and I had/have renewed the said Trade License time to time for smooth running of my small business. I had taken the Commercial Electricity connection from the electricity department in the year of 2000. I had/ have been paying the Holding Tax in respect of my said premises to the Siliguri Municipal Corporation regularly without fail.

I would like to further inform you that on and from the month of January, 2025, my adjacent neighbor namely Sri Jitendra Kumar Singh, Son of Late Krishnandan Singh of Ganganagar, Road No. 2, Santoshi Nagar, Burdwan Road, P.O. & P.S. - Siliguri Dist Darjeeling has started to disturb my peaceful possession and business with a plea that I have violated the rules of the municipality in regard to my said construction of old building and premises which I had built in the year of 2000 and he demanded a sum of Rs. 10,00,000/- (Rupees Ten Lakhs) from my husband but on refusal to fulfill his said illegal demand, said Sri Jitendra Kumar Singh has threatened my husband by saying that his brother is a political person and he will leave no stone unturned for demolishing my said construction.

I would like to further inform you that said Jitendra Kumar Singh somehow managed to convince the Siliguri Municipal Corporation and the said authority has given a direction in the name of my husband for demolishing the illegal portion of the said old construction of my premises. After getting the said notice, I had made an elaborate representation/complaint regarding the said illegal demand of money by said Mr. Singh from my husband to the Mayor and Commissioner of Siliguri Municipal Corporation and after the said complaint, Mr. Singh has came to my place on 03.08.2025, and misbehaved with me abusing filthy languages and on protest as made by my husband, said Mr. Singh physically assaulted my husband with kicks and

blows infront of the local people in the daylight and hurled upon my husband in a loud voice that "...saala chhota jaat, tera aukat nahi hai Bhumihar Jaat ke barabari me rahne ka" and also threatened by saying that he will demolish my entire premises at any cost.

I would like to further inform you that I had/have been residing and running my small stationery shop for earning the bread for my family since more than 25 (twenty-five) years without disturbing any of the adjacent cooccupants in any manner including the residence of Mr. Singh but said Mr. Singh is disturbing my peaceful physical possession with an intention to extort money and due to failure to grab the said money from my husband, he is giving our family an animal like treatment without human dignity as my husband belongs to a scheduled caste community.

That on 04.08.2025 I have went before the Siliguri Police Station to lodge this instant complaint and as per the instructions of the Inspector-in-Charge of the Siliguri Police Station I was directed to lodge the instant complaint before the concerned police station and in compliance to the said directions I am coming before you. That the delay in lodging this complaint is totally unintentional and without any sort of malice from my end.

Under the above circumstances, I would like to request you to investigate the matter and do the needful for the ends of justice.
