Choto bhai and few others all are the President of Ambikanagar, Ghatpara, stopped me and restrain me, suddenly they started demanding money and upon denial they approached me with a big knife in hand and, without any provocation, launched a brutal attack aimed at severing my hands. The above named persons struck multiple times with the knife, causing deep and grievous injuries to my right hand. They even threatened me that if I take any hold of legal course they shall put my life to an end. Considering such facts and circumstances, it is my humble request to acknowledge this written complaint and take the appropriate legal action against the above named persons under the due course of law.
