With profound respect and humble submission, I the undersigned, owner of Bike Rental Service of Bengal Riders, situated at NJP, Near Central bank, Aurobindo Ashram Road. would like to lay down the following few lines of prayer under your kind and sympathetic consideration that I had given 1 Royal Enfield Classic Reborn bike bearing Registration No. WB74BL5459 to Mr. Divya Prakash and Keshav Shukla took our bike on rental basis. Resident of HarraKh, Kapashiya, NH-31, Opp Bharti School, Begusarai, Bihar – 851101 on rented basis from 26th May 2025, They assured us that they have come all the way from Begusarai Bihar to visit Darjeeling and surrounding off-beat areas.

They had to return the bikes on 28th May 2025, but due to some reason they could not return the bikes on the said date and on 29th May 2025 Morning, they called us and told that they would like to extend the returning dates for two more days i.e. till 30th May 2025.

As I have already installed the GPS in my bike, I was tracking the bike thoroughly and on 30th May 2025 we found that the bike had reached Siliguri and its last tracking location was Opposite Sky Building Matigara. And when we tried to call them to return the bike, we found that both of their mobile phones were switched off.
