On dated 5th Aug 2025 at about 1015 hrs , As per existing SOP during through checking at duty point No. 03 at ICP Fulbari , incoming empty Vehicles from Bangladesh with the help of under vehicle search mirror , of trade truck registration no BP2B1762 one BD national was found hidden under the undercarriage (he was seating on the tyre lifter at the centre of the vehicle) . The apprehended BD national was trying to illegally enter into Indian territory and was apprehended by alert and active BSF personal on duty at the POO at ICP FULBARI.

The said BD national has hidden himself under the undercarriage of the truck no -BP2B1762 while this truck was returning back without any load to India as per trade rout . Truck no-BP2B1762 has gone to Bangladesh at about 041530 hrs through ICP Fulbari with load of stone boulders


