Sir,

In producing herewith the seized articles viz:-

- a) Total 02(two) packets of "KANTA" rice bran Oil seems to be adulterated manufacture date July 25 Net Weight 830 gram and marked as Exhibit "A"
- b) One Packets of "KANTA" rice bran Oil seems to be adulterated taken as sample from Exhibit A and marked as Exhibit "A-1"
- c) Total 02(two) Packets of "KAUSTAU" Rice Bran Oil seem to be adulterated MFG Date July 2025 Net Weight 730 Gram and marked as Exhibit "B"
- d) One(one) of "KAUSTAU" Rice Bran Oil seem to be adulterated and taken as sample from Exhibit "B" and marked as Exhibit-"B-1"
- e) 02(two) Packet of "SHIV TANDAB" Rice Bran Oil seems to be Adulterated and marked as Exhibit –"C"
- f) One packet of "SHIV TANDAB" Rice Bran Oil seems to be Adulterated taken as sample from Exhibit-"C" and marked as Exhibit "C-1"
- g) Total 02(two) packets of Refined Soyabean Oil styled 'MANBAN' Seems to be adulterated and marked as "Exhibit- D"
- h) 01 One packet of Refined Soyabean Oil styled 'MANBAN' Seems to be adulterated and taken as sample from Exhibit-D and marked as "Exhibit D-1"
- i) Two 02 Pieces plastic bottle "VASTAV" seems to be Adulterated net weight 350 ML Mfg. Dtd. July 2025 and marked as "Exhibit- E"
- j) 01(one) Piece plastic bottle "VASTAV" seems to be Adulterated and and taked as sample from "Exhibit- E" marked as "Exhibit- E-1"
- k) Total 12 (Twelve) Bottle of kachchi ghani mustard oil styled as " KIRAN SHREE" expiry date January 2022 seems to be adulterated and marked as "Exhibit-F"
- l) 01(one) Bottle of kachchi ghani mustard oil styled as " KIRAN SHREE" seems to be adulterated taken as sample and marked as "Exhibit-"F-1"

Seized from the possession of Tanishq Agarwal (27) S/O Sri Shib Kumar Agarwal owner of "Mateswari Food Products situated Jatiakali Fulbari , P.S New Jalpaiguri, Dist- Jalpaiguri under proper seizure list.

I, SI Raju Sarkar of Enforcement Branch, Siliguri Police Commissionerate do hereby lodged this written complaint against the accused person namely Tanishq Agarwal (27) S/O Sri Shib Kumar Agarwal owner of "Mateswari Food Products" situated Jatiakali Fulbari, P.S New Jalpaiguri, Dist- Jalpaiguri. I beg to inform that on 05.08.2025 received source information that an adulterated edible oil are preparing in the factory styled as "Mateswari Food Products situated Jatiakali Fulbari , P.S New Jalpaiguri, Dist- Jalpaiguri. Hence I diarized the matter vide EB, SPC GDE No.29 Dt. 05.08.25 I informed the matter to ACP(EB) SPC , as per instruction of ACP (EB) SPC I, along with the officers and force of EB ,SPC left for the spot via EB SPC GDE No. 30 Dtd. 05.08.2025. We reached at the Factory styled as "Mateswari Food Products" and after Inspection it came to know that they are preparing different types of

above seized food products in an unhygienic way with an illegal motive. During searched we could found the workers of the factory was packaging the, above noted seized edible oil in very unhealthy, unhygienic and unsafe condition and intermixing of various kinds of edible oil alongwith mixing of other products with edible oil. Packaging of food products and such mixing and adulteration will lead to spread of infection of diseases dangerous to life and may have other harmful and poisonous effects on humans consuming the said edible oils. On further search we could recovered the above noted articles in presence of owner ,witnesses and workers on interrogation owner of this factory was running this illegal "Mateswari Food Products" factory without any valid documents for the purpose of selling in open market for his wrongful gain.

Subsequently I seized the above noted articles in presence of owner namely Nabin Agarwal S/o Babulal Agarwal and independent witness namely

1) Manoj Kamti (35) S/O Batohi Kamti of matigara Vill- Kholai Boutari, Tumbajoit P.S Matigara, Dis- Darjeeling


2) Partha Midya (28) Shyama Prasad Midya of Vill -Gelia, P.O- Gelia, P. S jaipur, Dist- Bankura, WB duly obtained their signature.

After preparing proper seizure list with label as the owner did not produce any valid documents in support of manufacturing and storing such type of adulterated and noxious food products. As the above noted accused person violated the provision of law knowingly that the same is unhealthy and noxious to the consumers. Accordingly I seized the entire above noted article under proper seizure list. The seizure was made in between 18:55 hrs to 19:50 hrs.

Hence, I request you that a specific case under section 272/274/275 BNS and other applicable sections of applicable laws may kindly be started against the accused person namely Tanishq Agarwal (27) S/O Sri Shib Kumar Agarwal owner of "Mateswari Food Products situated Jatiakali Fulbari , P.S New Jalpaiguri, Dist- Jalpaiguri and arrange for its investigation.


