Sir,

With due respect and humble submission I ASI Nirmal Kumar Singha of Matigara P.S do hereby lodge this written complaint to the effect that today on 08/08/2025 I was deputed to perform special Raid duty along with force, since 06:00 hrs vide Matigara P.S. Online C.C. No. 57/25, Dated 08/08/2025 and GDE No. 406, Dated - 08/08/2025. In course of said special raid duty I received a source information that one Truck (Dumper) is coming from Balasan River loaded with River bed Materials towards Khaprail More which was procured clandestinely. On receipt of such information, I informed the matter to I/C Matigara PS over phone and as per his kind direction myself along with force rushed to Balasan River side and on way near Patan Fulbari bridge under P.S.- Matigara we found one Vehicle TATA Truck (Dumper) bearing Regn. No. WB 73 E 8386 loaded with river bed materials (Bolder) was speedily running towards Khaprail More. We managed to stop the vehicle and on demand the driver/owner of the vehicle could not produce any valid documents in favour of the said load. It is crystal clear that the driver/owner of the vehicle TATA Truck (Dumper) bearing Regn. No. WB 73 E- 8386 is procured the river bed materials from somewhere clandestinely and was proceeding to sale the same to their designated customer for their wrongful gain. Accordingly I seized the vehicle having Regn. No. WB 73 E- 8386 loaded with River Bed Materials (Bolder) with proper seizure list also arrested the driver of the seized vehicle namely Suresh Barman (23 Yrs/Male) S/O Kartik Barman of Bastuvihar, Pachkelguri, P.S. Matigara Dist. Darjeeling. Brought the seized vehicle to Matigara P.S and kept at P.S Compound and the arrested accused person kept into the P.S Lock up, maintaining all formalities and Hazat rules. The Seizure was made at 07.55 Hrs. on 08.08.2025 under proper videography.

I therefore pray before you that a specific case under proper section of Law may kindly be registered against the arrested accused driver of the seized vehicle namely Suresh Barman (23 Yrs/Male) S/O Kartik Barman of Bastuvihar, Pachkelguri, P.O. Nemai, P.S. Matigara Dist. Darjeeling and arrange for it's investigation.
