Respected Sir,

In producing herewith 02 arrested accused persons namely (1) **Bapi Roy @ Tapas 25 yrs S/O Lt. Brarmanda Roy of Anandyabari, near Krishna Mandir. P.O. Mirjapur, P.S. Patia, Dist. Kishanganj, Bihar** (2) **Sawan Sah 19 yrs S/O Rakesh Sah of Santoshinagar, W/No. 5, P.S. Siliguri, Dist. Darjeeling** along with the following seized articles under seizure as per seizure list:

- (i) **30 (Thirty) Bottles of Cough Syrup Styled as Rexstar -CD Cough Linctus each bottle containing 100 ML having Composition, Chlorpheniramine Maleate IP 4mg, Codeine Phosphate IP 10 mg , Sodium Citrate IP 75 mg, Flavoured Syrup Base q.s(Total weight 30pcs X 100 ML=3000 ML = 3 Ltrs) B,No.AL 5758, MFG.OCT.2023 EXP SEP 2025 kept inside one colour black pack from the joint and conscious possession of the accused persons namely (1) Bapi Roy @ Tapas and (2) Sawan Sah and marked as Exhibit 'A'.**

I, SI Abhishek Theengh S/O Suchandra Kumar Theengh of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above mentioned accused person to the effect that on 08.08.2025 at about 21:45, received a reliable source input that two male persons was standing at P.C Mittal bus stand, Sevoke Road under Bhaktinagar PS with huge quantity of illegal cough syrup for delivering the same to their designed customers at Siliguri area for their wrongful gain. The matter was diarized in Bhaktinagar PS vide Bhaktinagar PS GDE No. 375 dated 08.08.2025 and subsequently, I informed the matter in written to the I/C Bhaktinagar PS, SPC and being directed, at about 21.55 hrs myself along with SI Lawang Bomzon, ASI Dipak Karmakar, C/512 Dhar Mohan Singha, C/374 Debraj Biswas and C/1427 Swapan Roy, all of Bhaktinagar PS along with investigation kit left for P.C.Mittal bus stand, Sevoke Road by Govt. vehicle to verify the veracity of the information. This refers to Bhaktinagar PS GDE No.377 dated 08.08.2025 and M.C.C No. 3850/2025 Dated 08.08.25.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter at about 22:10 hrs we reached at P.C Mittal bus stand, Sevoke Road PS Bhaktinagar and meanwhile requested two independent witnesses namely 1. Shaswat Chowdhury 22 yrs S/O Ranjt Kumar Chowdhury of Gandhi Nagar P.S Bhaktinagar Dist Jalpaiguri 2. MD. Ramzani 27 yrs S/O MD. Elias of Gandhi Nagar P.S Bhaktinagar Dist Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them in writing to accompany us in the whole process during search and seizure, if any and they gave in writing about their approval to accompany Police during raid, search and seizure. After sometime and being pointed by my source we found two male persons standing together with one black colour bag and thereafter without any delay we detained two male persons at P.C Mittal bus stand, Sevoke Road PS Bhaktinagar. We disclosed our identity and the information in hand and stated him that they will be searched in person for the purpose. At this, they disclose their name and address as noted above and also found that both of them were holding one black colour back pack in their hand. On being asked they admitted that they had illegally possessed Cough syrup in their possession for selling the same to their designed customers as per requirement for their wrongful gain.

I then gave them an option in writing whether they were willing to be searched in presence of an Executive Magistrate or Gazette Police Officer; on return they gave in written that they are willing to be searched in presence of Gazette Police Officer. Then I informed over telephone to Shri Samrat Mitra, Inspector In-Charge, Bhaktinagar Police Station to come to P.C Mittal bus stand, Sevoke Road, PS- Bhaktinagar and requested him to be present during search and seizure of the Cough syrup.

Accordingly at 22:35 hrs Shri Samrat Mitra, Inspector In-Charge, Bhaktinagar Police Station arrived at the spot as Gazette Police Officer and subsequently, under his supervision and in presence of witnesses the process of search of the detained persons was conducted following all formalities and accordingly recovered the above noted articles from the possession of above noted accused persons. Subsequently, being demanded by Shri Samrat Mitra, Inspector In-Charge, Gazetted Police Officer the detained persons failed to produce any valid document in support of possessing of the cough syrup.

Thereafter, I recovered one black colour back pack containing with total 30 (Thirty) Bottles of Rexstar -CD Cough Linctus each bottle containing 100 ML having Composition, Chlorpheniramine Maleate IP 4mg, Codeine Phosphate IP 10 mg, Sodium Citrate IP 75 mg, Flavoured Syrup Base q.s (Total weight 30pcs X 100 ML=3000 ML = 3 Ltrs) B.No.AL 5758, MFG.OCT.2023 EXP SEP 2025 which was kept inside in above noted bag. I seized the above noted articles at the spot under proper seizure list duly signed by the independent witnesses. I also labelled and sealed all the articles under the supervision of Shri Samrat Mitra, Inspector In-Charge of Bhaktinagar PS and witnesses and accused persons. The whole process of search & seizure has been audio & VDO graphed. The whole process of seizure was made in between 22:55 hrs to 23:20 hrs.

Being further asked, the apprehend persons namely (1) Bapi Roy @ Tapas 25 yrs S/O Lt. Brarmanda Roy of Anandyabari near Krishna Mandir. P.O. Mirjapur, P.S. Patia, Dist Kishanganj, Bihar (2) Sawan Sah 19 yrs S/O Rakesh Sah of Santoshinagar, W/No. 5, P.S. Siliguri, Dist. Darjeeling admitted in presence of Shri Samrat Mitra, Inspector In-Charge of Bhaktinagar PS and other witnesses that they procured the cough syrup clandestinely from elsewhere for the purpose of selling the same in high rate to his designed customer for their personal gain by illegal means. They also disclosed that they had been dealing in such business of procuring and selling of cough syrup illegally for last few months. Then, I arrested the above noted accused persons after observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest u/s 35 (3) of BNSS.



P.O Mirjapur P.S Patia Dist Kishanganj Bihar (2) Sawan Sah 19 yrs S/O Rakesh Sah of Santoshinagar W/No. 5 P.S Siliguri Dist Darjeeling and arrange for its investigation.
