Subject: FIR for Assault and Attempted Robbery

Respected Sir/Madam,

I, Abhishek Gupta, S/o Narottam Das Gupta resident of Lane No.3, Lokenath Nagar, Bagdogra, wish to lodge a complaint regarding an incident of assault and attempted robbery that occurred on 1st August 2025 between 11:00 PM to 11:30 PM in front of Canara Bank, Panighata More, under the jurisdiction of Bagdogra Police Station.

While I was parked near the ATM to withdraw cash and on a phone call, I opened my car door to grab my card. At that moment, two unknown bike-borne individuals approached me and began an unprovoked quarrel. After briefly leaving, they returned within minutes—likely noticing the area was deserted—and physically assaulted me. They punched me in the face, causing bleeding injuries to my lips and chin and an injury to my left ear. The attack was only stopped after a few individuals from a nearby building intervened. The attackers fled the scene, pretending it was a personal dispute. However, I confirm that I do not know them.

The intention appears to be robbery, and upon resistance, they assaulted me. One attacker's T-shirt was stained with my blood. Locals mentioned the names 'Ajay Dubey' and someone named 'Suman' from Gossainpur, Bagdogra, possibly linked to the incident.

I was in shock as I was already unwell since afternoon, and this has deeply disturbed me. A friend later took me to Bagdogra Hospital for a medical check-up as I was bleeding and could not hear properly from my left ear.

I request you to take strict legal action against the accused and register an FIR under relevant IPC sections for attempted robbery and physical assault.
