In producing herewith the accused person named Rabi Lohar (M/19 years), s/o- Bachan Lohar, resident of Kamalpur TE, Niche Line, opposite to Health Centre, PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following seized articles:

I, SI Binup Mahato of Bagdogra PS, SPC, do hereby lodge this written complaint against the above noted arrested accused person to the effect that today on 06.08.2025 at 19:35 hrs I received reliable source information that many stolen bicycles are kept concealed at his residence at Kamalpur TE under Bagdogra PS. Accordingly, I informed the matter to O/C Bagdogra PS and diarized the matter in GD vide GDE No. 270 dated 06.08.2025 and as per direction of O/C Bagdogra PS I formed a raiding team consisting SI Debabrata Kundu, ASI Amit Lama, C/1509 Sourav Roy Sarkar, CV/389 Janak Singh & CV/375 Jogesh Barman leaded by me. Then at 19:45 hrs we left for Kamalpur TE to work out the veracity of the source information vide Bagdogra PS GDE No. 271 dated 06.08.2025. At around 19:55 hrs we reached at Kamalpur TE under Bagdogra PS and after a while source indicated one suspect there. Accordingly, we apprehended the suspect and interrogated him. On interrogation, he disclosed his identity as Rabi Lohar (M/19 years), s/o- Bachan Lohar, resident of Kamalpur TE, Niche Line, opposite to Health Centre, PS- Bagdogra, Dist- Darjeeling (not verified) and confessed that he has alone stolen away many bicycles from the Bengdubi ARMY area and other areas under the jurisdiction of Bagdogra PS for a long time. He has kept concealed the stolen bicycles at his residence. He agreed to help Police to locate the place where he had kept concealed the stolen bicycles. Accordingly, we left for the place. He showed the place and identified the stolen bicycles. On being asked the suspect Rabi Lohar could not produce any valid documents/ purchase invoice in respect of the bicycles. Accordingly, I recovered total twenty-one (21) bicycles of different colours and sizes which
