Subject: Lodging of FIR regarding fraudulent attempt to sell ancestral tribal land by creating forged documents

I Rabi Oraon S/o Late Banku Oraon Resident of resident at village Labanujote, P.O.- New Chamta, P.S.- Matigara, District- Darjeeling, Pincode-734009, hereby lodge this First Information Report (FIR) stating the following facts for your kind consideration and necessary legal action:

That I, along with the following co-sharers and co-inheritors of the ancestral property, namely -

1. Ashok Oraon S/o Late Banku Oraon 2. Pramila Oraon, 3. Sarmila Oraon, both are D/o Late Banku Oraon, 4. Anita Oraon, W/o Late Bhagaban Oraon, 5. Suraj Oraon, S/o Late Bhagaban Oraon, 6. Sangita Oraon, D/o Late Bhagaban Oraon, 7. Manti Oraon, W/o Late Prem Oraon, 8. Ajita Oraon, D/o Late Prem Oraon and 9. Sujit Oraon, S/o Late Prem Oraon All are permanent residents of Village - Labanujote, P.O. - New Chamta, P.S. - Matigara, District - Darjeeling, Pincode - 734009, West Bengal. We are the legal heirs and successors-in-interest of Late Banku Oraon, the recorded owner as per R.S. Records. Upon his demise, we inherited the following land situated under: Mouza-Dhukuria, J.L. No. 53, R.S. Khatian No. 9, L.R. Khatian Nos. 56, 699, 897, 923, 137/1, 325, 326, 866, 867, 898, 899, 3098, 3189 and 3204, R.S. Plot No. 187, 194 and 195, L.R. Plot Nos. 232, 242 and 421 within Police Station : Matigara, in the District of Darjeeling by way of inheritance.

The said property is a **Tribal Land**, and we have been in peaceful and uninterrupted possession of the same and have full right, title, and interest over it.

However, recently we have come to know that above mention individuals are illegally attempting to sell our ancestral land to third parties by forging documents and preparing fake deeds. We also came to know that they have accepted large sums of money as advance from those third parties under false pretenses.

Upon learning this, we immediately approached the office of the BL & LRO to report the matter. Shockingly, we discovered that with the help of some unscrupulous officials/staff of the said office, those persons have fraudulently manipulated records and initiated unlawful conversion of our tribal land to transfer it to general category persons without our consent or knowledge.

This is a clear case of cheating, criminal conspiracy, fraud, and forgery with the intention to dispossess lawful tribal owners of their ancestral land.

Therefore, I humbly request you to kindly Investigate the matter thoroughly, and take strict legal action against the above mention persons along with their associates involved, including any government officials complicit in this illegal act, and take steps to prevent further alienation of our tribal land and oblinded.
