- 1. That I am one of the legal heirs of my late father KathirlankalTeressamma Chacko @ K.T. Chacko and my late mother Smt. Teresa Soren Chacko.
- That my deceased mother was the recorded owner of more than 600 decimals of land in Mouza Dulurchhat, comprising various plots under Khatian Nos. 25, 27/2, 74/1, and 27/1.
- 3. That my mother was a well-educated individual, serving as a teacher in a reputed institution.
